Underground Fuel Tanks

Introduction

This bulletin outlines the requirements to obtain a permit to remove or abandon-in-place (decommission) residential or commercial-type underground fuel or storage tanks that are not in use.

What are the requirements for removing or decommissioning an underground fuel or storage tank from a residential site?

Residential fuel-oil tanks that have not been used for one year shall be removed from the ground or may be abandoned-in-place in a prescribed manner.

"Tanks and piping serving oil-burning equipment which have been out of service for a period of one year shall be removed from the ground or abandoned in place in accordance with Section 3404.2.13.1.3 of the International Fire Code."

The following requirements must be met to to remove or decommission an underground tank:

- A. A residential tank decommission contractor approved by the King County Marshal's Office must be used for tank removal or abandonment. Contact the DDES Fire Marshal's Office at 206-296-6675 for a current list of approved contractors.
- B. The contractor will supply King County with certification that the tank was properly removed or abandoned (decommissioned). The home owner should request a copy of the rinse receipt and King County DDES Fire Marshal's tank certification from the tank decommission contractor. The rinse receipt acknowledges the tank has been cleaned per the requirements of the Department of Ecology standards. The property owner should maintain copies of these documents for future reference.
- C. A permit from King County DDES is not required for residential tank removal or abandoned inplace (decommissioned) tanks.

What are the requirements for obtaining a commercial permit to remove an underground storage tank?

Any commercial-type underground tank used to store flammable or combustible liquid that has been out of service for one year shall be removed from the ground. Under certain conditions, however, a commercial-type tank may be abandoned-in-place. For clarification on whether a specific commercial tank must be removed, contact the King County Fire Marshal's Office at 206-296-6675.

"Underground tanks which have been out of service for a period of one year shall be removed from the ground in accordance with Section 3404.2.13.1.3 of the International Fire Code and the site shall be restored in an approved manner."

Before removing any commercial tank, however, a permit must be secured from the King County Fire Marshal's Office, located within DDES. To obtain a permit for removing a commercial-type tank, applicants must submit the following information at the DDES Permit Center and apply for a Fire Tank Permit. No appointment is required.

Permits may be applied for by either of the following methods:

- 1. Applications may be mailed to the King County Department of Development and Environmental Services (DDES) located at 900 Oakesdale Avenue Southwest, Renton, Washington 98057-5212.
- Applications may be dropped off at the DDES Permit Center at the address above. For driving directions, simply log onto the DDES Web site at www.kingcounty.gov/permits. No appointment is necessary. To drop off an application, customers check in at the reception desk on the first floor and a representative from the Permit Center will provide assistance. Applications will be accepted between 8:30 a.m. and 4:30 p.m., Monday through Friday.

A. Cover sheet (three copies) showing:

- 1. The address of the property;
- 2. The name of the property owner; and
- 3. The Property Tax Account Number.

B. Drawings (three copies) showing:

- 1. All property lines and buildings on the property;
- The location of the tank(s) in proximity to buildings and/or property lines (indicate separation distances in feet);
- 3. The type of liquid the tanks held (fuel-oil, gasoline, etc.);
- 4. The size (in gallons) of the tank(s); and
- 5. A clear indication of actions to be taken regarding the tank(s) (specify removal of tank(s) or abandonment-in-place). A King County DDES fire protection engineer may allow abandon-in-place with special approval.
- 6. Tanks shall be inerted (exhibiting no chemical activity or completely inactive) prior to removal and verified by a marine chemist;
- 7. The tank(s) shall be removed from unincorporated King County and shall not be cut on site;
- 8. Commercial-type underground tanks shall be removed from the ground except when special approval is given to abandon in place;
- 10. A final inspection will be conducted of all commercial tank removal or decommissioning activities; and
- 11. Please call 206-296-6615 to request and schedule a fire inspection.

C. Additional information required:

- Identify the company/firm and the Washington State Contractor's Registration Number of the company/firm removing the tank(s) or abandoning the tank(s) in place. Issuance of a permit is limited to an individual or company holding a Washington State Contractor's Registration and who possess the knowledge, expertise, and necessary equipment for handling flammable or combustible liquid tanks.
- 2. If tanks are to be abandoned-in-place, indicate which material will be used to fill the tank:
 - Cement slurry mix; or
 - Approved foam agent.

Permit fees

The permit fees to remove underground tanks or abandon them in place are established by King County Ordinance [Title 27 of the King County Code (KCC)]. For information regarding current fees, contact staff at the Department of Development and Environmental Services (DDES) at 206-296-6600.

Note: All required fees are due at the time of permit application.
