

Release Notes 3.2.9/3.3.0 October 19, 2007 /October 26, 2007

The following items have been moved (migrated) to Production for use by Agencies beginning on October 19, 2007.

<u>IM125553</u> – Query HE0163

ISSUE: User reported query HE0163 timing out before returning results.

RESOLUTION: Query modified to perform more efficiently.

USER IMPACT: User can now run query HE0163 and return results as expected and in an acceptable timeframe.

IM125399 - Query HE0306

ISSUE: User request to add Manager Level to query results

RESOLUTION: Query updated as requested

USER IMPACT: Query HE0306- Vacant and incumbered positions - will now report Manager Level in addition to original fields.

<u>IM125402</u> – Query HE0337

ISSUE: User request to create new queries to report "late OPM actions"

RESOLUTION: Query HE0337 created

USER IMPACT: Users can now accurately report accurately on late OPM actions.

IM124670 – Manager Level Field

ISSUE: Users receiving EHRI Edit results to clean up discrepancy in Manager Level field but this field is not enterable on Position and/or Par Pages.

RESOLUTION: Modifications made to Position to allow users to update the Manager Level field. When a change is made to the Manager Level in Position Data it will be reflected in the PAR Pages.

USER IMPACT: Users can now clean up EHRI edits pertaining to Manager level discrepancies by themselves without opening a ticket and needing helpdesk/technical intervention.

The following items have been moved (migrated) to Production for use by Agencies beginning on October 26, 2007.

<u>IM125296</u> - Headcount status over allocated with 2 employees.

ISSUE: Headcount status in Position Data was incorrectly displaying a status of "Over allocated", when position was actually open and/or filled (but filled with only one active employee). This resulted in the users creating new positions when the current position was actually available.

RESOLUTION: Modification to logic generating the headcount status in position data to use empl_status.

USER IMPACT: Position data now accurately reflects the headcount status, thus users will not create new positions needlessly.

<u>IM123438</u> – This ticket dealt with multiple modifications dealing with Award Processing

ISSUE: (1) When processing a QSI, if new step value is 4 or 7, then the LEI date is not at least one year prior to the PAR effective date.

- (2) Two awards should not have the same PAR effective date.
- (3) All awards should have an award amount
- (4) Error when processing a QSI and exiting the Award Data page

RESOLUTION: (1) Modification to abort if the LEI date is not at least one year prior to the PAR Effective Date when the new step is 4 or 7.

- (2) Logic added to prevent to monetary or non-monetary awards from being inserted for the same PAR Effective date.
- (3) Logic added to force user to insert a dollar or hour amount, as appropriate for all awards. The only exception being an 827* NOA.
- (4) Modification to page processing to correct error message being received.

USER IMPACT: Each of these issues/modifications will ensure that the users can process award PAR actions correctly and successfully

<u>IM96363</u> – Batch SF50 printing

ISSUE: (1). Two error messages received upon entering the screen (2) When you click on the lookup icon for the two PAR status fields, no data was returned.

(3). Tab names were unhelpful ex. Tab1 displayed "HE Runctl Par" and Tab 2. displayed "Runctl Par 2"

RESOLUTION: (1) Modifications to prevent error messages.

- (2). Modifications to accurately display PAR Status field values.
- (3). Tab names were changed to display "SF50 Criteria" for tab 1 and "Filtered PAR Actions" for tab 2.

USER IMPACT: Modifications will allow users to successfully use the SF50 Batch printing process, as well as to make the page more user friendly.



IM124781 - Query HE0043 - Action processed within Dept.

ISSUE: Query HE0043 was not returning the name correctly in the result set for most employees.

RESOLUTION: Modification to query to pull name field from a custom view versus delivered.

USER IMPACT: Query will now accurately display name in result set.

IM124888- SSN edit

ISSUE: Employee hire could not be processed due to error being received on national id/ssn. Per the error message the national id/ssn had not been issued yet.

RESOLUTION: After national id/SSN was validated, the edit was removed to allow this national id/SSN to be saved.

USER IMPACT: All users can now enter national id/ssn that begins with the 3 digit series of 677.

IM125829- Query HE0058

ISSUE: IHS was unable to run query, as the query would timeout before results populated.

RESOLUTION: Changes were made to query HE0058 to speed up the results, results should populate in 24 seconds.

USER IMPACT: Users can now run the HE0058 query more efficiently, returning results in a more acceptable time frame.

<u>IM125926-</u> Query HE0338 & HE0339

HE0338 ISSUE: CDC would like to change the "Open Data From and To" to "Job Opening Status Date From and To", because the Open Date is not a static date, but the status date is static to the current status. This date would be more accurate for our purpose. Current search criteria are: Business Unit, Deptid Like (%for all), Job Opening Status (% for all), Open Date From, Open Date To.

RESOLUTION: Created query HE0338 – Job Requisition by Status Date with search criteria to: Business Unit, Deptid Like (%for all), Job Opening Status (% for all), Job Opening Status Date From, Job Opening Status Date To.



USER IMPACT: Users can now accurately report on Job requisitions by status date.

HE0339 ISSUE: CDC would like update HE_ALL_WIP_STATUS_PAR by adding the WIP Status to the search criteria, and change the title in the search criteria of the "Action Date" fields to read "Status Date". Current search criteria are: Action Begin Date, Action End Date, and Business Unit.

RESOLUTION: Created new query HE0339- PARS by Status Date with search criteria to: Business Unit, Dept Like (%for all), WIP Status (% for all), and Status Date From, Status Date To:

USER IMPACT: Users can now accurately report on PARS by status date.

IM125492- Query HE0010

ISSUE: IHS states that the query should not populate inactive employees only active.

RESOLUTION: Query recreated to accurately return correct employees.

USER IMPACT: Users can now run HE0010- Staffing Runs – pulling only active employees as expected.
