Each applicant will be issued an identification code (user-id) that will be required each time they access a SEFSC server. The id is established at the SEFSC by an approving official within the Information Resources Division.

The application form consists of four sections: Applicant Information, Authorization, Access Method, and Server Usage. Applicants that are designated the responsibility of managing one of the Data Collections systems must have their official submit a SEFSC Systems Access Supplement - Data Collection Management Authorization form.
