HANFORD ADVISORY BOARD (HAB) ADVICE #161 – DIVERSITY OUTREACH

Reference: HAB letter from T. Martin to K. Klein, RL; R. Schepens, ORP; L. Hoffman, Ecology; and, J. Iani, EPA, "Diversity Outreach," dated June 4, 2004.

Thank you for the HAB's recent advice on expanding public outreach to diverse populations and your recommendation that we begin our efforts by focusing specifically on Spanish-speaking residents.

The agencies agree that public information and participation activities must be "broad and inclusive" and "open and accessible." We are pursuing alternative public participation approaches designed to improve the accessibility of information to Spanish-speaking communities, as well as other under-represented groups.

Based on discussions with the Public Involvement & Communication (PIC) committee, we are already moving forward with providing information to area media outlets that target Spanish-speaking residents. Additionally, our public involvement staff will continue to work with the PIC committee to identify and implement strategies that will help us expand our outreach and improve the level of public input into the decision-making process.

We look forward to an ongoing dialogue about this issue and thank you again for your feedback.
