DUTIES: This position is located in the Emergency room, within the department of Ambulatory Care Nursing, at the Gallup Indian Medical Center. Incumbent performs receptionist, recordkeeping and miscellaneous clerical duties associated with patient care and treatment in the Emergency Room (ER). Registers for medical records of patients receiving care in the ER and assists in the identification of patients as necessary. Assures that patients are properly logged into the ER log book and patient forms are instituted. Assures that physician orders such as labs, x-rays, referrals, etc., are transferred to the appropriate forms and routed to the appropriate department. Deliver laboratory specimens with appropriate requisitions. Files results of various tests and visit records in patient medical record. Prepares patient records for discharge, transfer, or admission and verifies completeness of records, ensuring that all necessary documents are filed before the medical record is returned. Provides notification of admission to Admissions Office. Provides notification of transfers to Contract Care utilizing Registration Patient Management System (RPMS). Assists nursing staff with transport transfer arrangements. Received telephone calls to the unit and directs calls to the appropriate personnel. Assists with scheduling appointments for various specialty clinics. Utilize the RPMS appointment system when scheduling patients follow-up appointments. Arrange for patient appointments and referrals to outside hospitals and physicians. Orders and maintains supplies, including clerical and medical supplies for the Emergency Department. Maintains and stocks all categories of super-bills appropriately. Assist with super-bill circulation in the ER and back to PCC data entry department. Ensures copies of blank super-bill encounter forms are in the medical chart for each ER encounter. Assist the department with Quality Assurance/Performance Improvement Program with clerical functions, data collection, and retrieval of data from the Emergency Room Log. Performs other related duties as assigned.

QUALIFICATION REQUIREMENTS: YOUR DESCRIPTION OF WORK EXPERIENCE, LEVEL OF RESPONSIBILITY, AND ACCOMPLISHMENTS WILL BE USED TO DETERMINE THAT YOU MEET THE FOLLOWING REQUIREMENTS:

EXPERIENCE AND EDUCATIONAL REQUIREMENTS: For GS-05: 52 weeks of specialized experience equivalent to at least to GS-04; or 4 years of education above high school.

SUBSTITUTION OF EDUCATION FOR EXPERIENCE: Successfully completed education above the high school level in any field for which high school graduation or the equivalent is the normal prerequisite. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university. One year of full-time academic study is defined as 30 semester hours, 45 quarter hours, or the equivalent in a college or university, or at least 20 hours of classroom instruction per week for approximately 36 weeks in a business, secretarial, or technical school.

SPECIALIZED EXPERIENCE: Experience that equipped the applicant with the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of a Medical Support Assistant, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level. Examples of specialized duties are: This includes thorough knowledge of emergency room policies/procedures to receive and follow through on patient requests for treatment, medical, technical and specialized medical terminology common to the ER to record orders, x-ray and test reports, obtain/review patient medical records, schedule patient appointments, give preparatory instructions to patients for a variety of procedures, and record, report, and file patient information. This includes the practical knowledge of computerized data entry and information processing systems of the medical facility's organization and services.

CONDITIONS OF EMPLOYMENT: Incumbent works on regularly scheduled rotational shifts to provide continuity of various clerical duties during evenings, weekends and holidays.

LICENSURE REQUIRED: None

IMMUNIZATION REQUIREMENT All persons born after 12-31-56, must provide proof of immunity to Rubella and Measles. Serology testing to confirm immunity and/or immunizations will be provided free of charge. WHO MAY APPLY:

Merit Promotion Plan (MPP) Candidates. Applications will be accepted from status eligibles (e.g., reinstatement eligibles and current permanent employees in the Competitive federal service), and from current permanent IHS employees in the Excepted federal service who are entitled to Indian Preference.

Excepted Service Examining Plan (ESEP) Candidates: Applications will be accepted from individuals entitled to Indian Preference. Current permanent IHS Excepted service employees and Competitive service employees or Reinstatement eligibles entitled to Indian Preference may also apply under the provisions of the Indian Health Service Excepted Service Examining Plan. These candidates **MUST** indicate on their "Application for Federal Employment" whether their application is submitted under the **IHS Excepted Service Examining Plan, the IHS Merit Promotion Plan, or both.**

NOTE: Applications will also be accepted from individuals eligible for non-competitive appointment (e.g., applicants eligible for appointment under the Veterans' Readjustment Act, the severely handicapped, or those with a 30% or more compensable service-connected disability).

The following categories of candidates are considered displaced employees.
 - A. Current or former career or career-conditional (tenure group I or II) competitive service employees who:
 1. Received a specific RIF separation notice; or
 2. Separated because of a compensable injury, whose compensation has been terminated, and whose former agency certifies it is unable to place; or
 3. Retired with a disability and whose disability annuity has been or is being terminated; or
 4. Upon receipt of a RIF separation notice retired on the effective date of the RIF and submit a Standard Form 50 that indicates "Retirement in lieu of RIF;" or
 5. Retired under the discontinued service retirement option; or
 6. Was separated because he/she declined a transfer of function or directed reassignment to another commuting area.

- B. Former Military Reserve or National Guard Technicians who are receiving a special OPM disability retirement annuity under section 8337(h) or 8456 of Title 5, United States Code.
2. Be applying for a position at or below the grade level of the position from which you have been separated. The position must not have a greater promotion potential than the position from which you were separated.
3. Have a current (or last) performance rating of record of at least fully successful or equivalent. This must be submitted with your application package. (This requirement does not apply to candidates who are eligible due to compensable injury or disability retirement).
4. Occupy or be displaced from a position in the same local commuting area of the position for which you are requesting priority consideration.
