**AREA OF CONSIDERATION:** Special area of consideration limited to the Local Commuting Area - Management determines in advance that there is likely to be an adequate number of qualified applicants in the local commuting area. Outside non-Indian preference candidates will not be considered when using special areas of consideration.

**RELOCATION:** Relocation expenses will not be paid. Employees who wish to relocate to Mescalero, New Mexico for their own benefit may apply. If there are no Indian preference eligible candidates within the commuting area and an Indian preference candidate is selected from outside the commuting area, relocation costs will be paid.

#### **CONDITIONS OF EMPLOYMENT:**

- One temporary full-time position not-to-exceed one year. The incumbent of this position is subject to call back and/or standby work
- ➤ If you are a male, born after December 31, 1959, and you want to be employed by the federal government, you must (subject to certain exemptions) be registered with the Selective Service System.
- In accordance with Chapter 12, Indian Health Manual, IHS Employee Immunization Program, selected candidate will be required to submit proof of immunity to the following diseases: Rubella and Measles.
- ➤ Before hiring, the IHS will ask you to complete a "Declaration for Federal Employment" and/or "Addendum to Declaration for Federal Employment Indian Health Service Child Care & Indian Child Care Worker Positions" to determine your suitability for federal employment, to authorize a background investigation, and to certify the accuracy of all information in your application. Under P.L. 101-630 Indian Child Protection Act, anyone who answers in the affirmative will be found ineligible and unsuitable for employment in the Indian Health Service. If you make a false statement in any part of your application, you may not be hired; you may be fired after you begin work; or you may be fined or jailed.

#### DUTIES AND RESPONSIBILITIES:

The purpose of these positions is to provide direct patient care and maintenance of the environment for care. Perform a variety of responsible nurse care tasks involving standardized procedures requiring knowledge and consideration of specific patient conditions and treatments. Performs direct patient care with primary consideration for the patient's safety, dignity, comfort, age/development stage and cultural specifics. Performs personal nursing care duties such as feeding, bathing, lifting, turning, oral care and personal hygiene duties. Recognizes and reports significant changes in patient's condition. Supports diagnostic duties, which includes taking, recording and reporting to the licensed nurse any deviations in vital signs, collecting, labeling, and transporting specimens to the laboratory. Assists the nurse/doctor in position/draping for examinations. Monitors the administration of intravenous solutions for low levels, interruptions in flow and reports to licensed nurse. Gathers and reports specific information from the patient to licensed nurse. Assists in admitting and discharging of patients. Transporting patients by wheelchair/stretcher, and escorting patients within the hospital. May accompany patients requiring uncomplicated care being transported to other facilities with responsibility for the continual assessment of patient's condition and applying appropriate life sustaining techniques. Observes patient's behavior and maintains a safe environment. Performs as part of the multi-disciplinary team in providing Patient and Family education related to needs identified for specific patients groups and/or individuals. Special duties are assigned consistent with specific training such as:

Assistance with sexual assault exam to include preparation of patient, emotional support, preparation of evidence collection kit, appropriate handling of evidence specimens during exam, notification of appropriate referral. Interpreting for non-English speaking patients to assure understanding of medical/nursing treatment and patient/family concerns/participation in medical care. Maintains and updates professional knowledge through attending training as designated by supervisor related to current Ambulatory/Emergency nursing practice, such as equipment in-services, cultural sensitivity, skills updates, EEO, information management, in-services related to commonly seen seasonal disease processes, and disease processes specific to population served.

#### COMPETITIVE AND EXCEPTED SERVICE QUALIFICATION REQUIREMENTS:

Candidates must have had 26 weeks of General Experience and 26 weeks of Specialized Experience **OR** 2 years above high school with courses related to the occupation, if required.

**General Experience:** (1) Any type of work that demonstrates the applicant's ability to perform the work of the position as shown under "Duties and Responsibilities" or (2) experience as a trainee in providing assistance to the nursing and medical staff. Adheres to general safety to transport patients within the departments or hospital. Has basic knowledge of medical terminology or anatomy and physiology to record information in patient medical records.

**Specialized Experience:** Qualifying specialized experience includes nonprofessional nursing care work in a hospital, outpatient clinic, nursing home, or other medical, nursing or patient care facility, or in such work as that of a home health aid performing duties such as:

- Providing personal nursing care such as providing pre- and post-operative care.
- Support duties for diagnostic and technical treatment procedures, such as setting up and operating special medical equipment and apparatus.
- Caring for mentally ill patients, including observing, recording, and reporting changes in their behavior, and providing reassurance and encouragement.
- Assisting surgeons and registered nurses in operating room activities, including passing instruments, maintaining sterile conditions, and draping and positioning patients.

#### OR

**Education and Training:** Successful completion of a 2-year degree program in an accredited community college, junior college, or college or university in practical nursing or in a field of study appropriate to the specialization of the position, such as education in a program for a psychology, psychiatric, or operating room technician. It is the applicant's responsibility to provide documentation or proof; i.e., official transcript, etc.

**EVALUATION METHOD AND RANKING FACTORS:** Evaluation will be made of the extent to which experience, education, training, self-development, performance appraisal, outside activities, and/or awards demonstrate that basically qualified candidates possess the Ranking Factors-KSAs described below. It is to the applicant's advantage to address the following KSA's on a separate sheet of paper.

- 1. Ability to provide basic nurse aid services.
- 2. Ability to assist with medical procedures and perform simple technical procedures.
- 3. Ability to communicate and document nursing services provided.

#### WHO MAY APPLY:

Merit Promotion Plan (MPP) Candidates: Applications will be accepted from status eligibles (e.g., reinstatement eligibles and current permanent employees in the competitive federal service) and from current permanent IHS employees in the Excepted Service who are entitled to Indian preference.

**Excepted Service Examining Plan (ESEP) Candidates:** Applications will be accepted from individuals entitled to Indian preference. Current permanent IHS Excepted Service employees and competitive service employees or reinstatement eligible entitled to Indian preference may also apply under the provision of the Indian Health Service Excepted Service Examining Plan.

Candidates <u>MUST INDICATE</u> whether their application is submitted under the IHS Excepted Service Examining Plan, the IHS Area Merit Promotion Plan, or both.

Applications will also be accepted from individuals eligible for non-competitive appointment (e.g., applicants eligible for appointment under the Veterans Readjustment Act, the severely handicapped, those with a 30% or more compensable service-connected disability).

**Indian Preference**: Indian Health Service is required by law to give absolute preference in employment to qualified Indian preference candidates.

**Veterans Preference:** Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 years or more of continuous active service may apply.

**Reasonable Accommodations:** This agency provides reasonable accommodations to applicants with disabilities. The decision on granting reasonable accommodation will be made on a case-by-case basis.

<u>Career Transition Assistance Program (CTAP)/Interagency Career Transition Plan (ICTAP):</u> Surplus or displaced employees covered by the U.S. Department of Health and Human Services CTAP program or the ICTAP program for all agencies, may apply and will be given special selection priority if determined to be eligible and well qualified. <u>Well qualified</u> is defined as meeting all education, experience, knowledge's, skills and abilities (KSA's) with a score in the above average range of a four-level crediting plan for all KSA's. #### **REQUIRED DOCUMENTATION:**

- ➤ Verification of Indian Preference: Applicants who wish to receive Indian Preference MUST submit the BIA Form 4432, Verification of Indian Preference for Employment in BIA and IHS only. This certifies the applicant as an Indian as defined by the Indian Health Manual, Chapter 3, Indian Preference, dated March 14, 2001. Indian preference will not be given unless the BIA Form 4432 is attached to the application/Résumé.

- > To substitute education for experience, where applicable, you must submit a copy of your transcripts by the closing date or ensure that your resume includes sufficient detail (i.e., required course title, credit hours and grades) to document that you have met the education requirements. Official transcripts will be required prior to entry on duty.

#### OTHER IMPORTANT INFORMATION:

- ➤ All material submitted for consideration under this announcement becomes the property of Division of Human Resources and is subject to verification. Therefore, careful attention should be given to the information provided. Fraudulent statements or any form of misrepresentation in the application process could result in loss of consideration for this position and/or a determination of unsuitability for federal employment.
- Additional or alternate selections may be made from a promotion certificate within 90 days from the date the selection certificate was issued. The positions to be filled must have the same title, series, and grade, be in the same geographic location and have the same qualification requirements. However, if there are no qualified Indian preference candidates left on the certificate, the vacancy <u>must</u> be re-announced.

➤ EQUAL EMPLOYMENT OPPORTUNITY: Except for Indian preference, consideration will be given without regard to any non-merit factor such as race, color, religion, sex, national origin, partisan politics, physical or mental handicap, marital status, age, membership or non-membership in any employee organization, or sexual orientation.
