Special Session 2005

On July 12, the state Legislature voted to override 12 out of 28 bills that Governor Lingle vetoed. Below are the bills that were passed into law after the one-day special session.

- **SB 960** Funds for natural disaster preparedness efforts and improves the loss mitigation grant program. The loss mitigation grant program was set up to assist residents with installing wind resistive devices to protect their property against hurricanes. Grants are also provided for safe rooms for residents who may not be able to afford reinforcement of their entire home. **Vote count: 24-0**
- **SB 1473** Requires Department of Health to give notice to the local neighborhood, the Legislature and obtain approval of the Governor for any use of state-owned land under its jurisdiction in the Waimano Ridge area prior to use of the land as a sex offender treatment facility, drug treatment facility, state laboratory, or any other uses. **Vote count 23-1**
- **SB 1592** Creates a task force to develop the Hawai'i 2050 sustainability plan. **Vote count: 24-0**
- **SB 1808** Prevents excessive changes to worker's compensation laws through administrative rulemaking procedure. **Vote count 19-5**
- **SB 1262** Suspends the issuing of state small boat harbor permits for ocean use activities until the boundaries of an ocean recreational management area from Kalaeloa Point to Kaena Point are determined and rules are adopted and require the Department of Land and Natural Resources (DLNR) to prepare an environmental study to assist in the drafting of rules for the area. **Vote count: 24-0**
- **SB 1685** Allows state taxpayer information to be shared with the counties. **Vote count: 24-0**
- **SB 1772** Requires each applicant for medical assistance to identify their employer and requires the Department of Human Services (DHS) to submit an annual report to the Legislature identifying all employers who employ 25 or more beneficiaries of medical assistance programs. **Vote count: 19-5**
- **SB 1877** Clarifies that the Department of Business, Economic Development, and Tourism (DBEDT) has sole authority over land use and state planning functions and that the Office of Planning shall report to DBEDT. **Vote count: 20-4**
- **HB 160** Increases clarity, accountability, and fairness in state assessments of insurers and in the use of those funds. **Vote count: 19-5**
- **HB 180** Provides equality in compensation and benefits for exempt civil service employees that are at least equal to the adjustments under collective bargaining agreements for their counterparts and subordinates. **Vote count: 20-4**
- **HB 1224** Establishes procedures, requirements, standards, and guidelines for compliance with the streamlined sales and use tax agreement. **Vote count: 21-3**
- **HB 1317** Prohibits the Department of Human Services (DHS) from taking any action to remove pharmaceutical benefits management from managed care plans for Medicaid beneficiaries. **Vote count: 19-5**

2005 SESSION HIGHLIGHTS

MILITARY

The 2005 Military Appreciation Package was created to support the efforts of our men and women in uniform throughout Hawai'i. As a beneficiary of their courageous and dedicated service, the State bears a special responsibility toward United States forces. The pieces of legislation that comprise the Military Appreciation Bill Package address some of the many challenges facing our military personnel and their families.

Hawai'i Medal of Honor

Establishes the Hawai'i Medal of Honor, in appreciation for military personnel with Hawai'i ties who are killed in action since 2003.

Hawai'i State Veterans Cemetery; UH Military Students; Uniform Maintenance Allowance Direct Deposit

- Appropriates \$187,450 for casket liners and to address soil problems at the Hawai'i State Veterans Cemetery
- Authorizes the right of returning members of the military to retain readmission to University of Hawai'i programs
- Allows enlisted army or national guard members to elect direct deposit for their uniform maintenance allowance.

Professional & Vocational License Renewal

Relaxes license restoration requirements for Department of Commerce and Consumer Affairs (DCCA) licensees who are deployed during state or national crisis.

Hawai'i Veterans' Newsletter

Appropriates \$30,000 for the Office of Veterans Services to publish the Hawai'i veterans' newsletter and to update the veterans' database.

Pearl Harbor Historic Trail

Designates the path from Halawa landing to Waipahu as the Pearl Harbor Historic Trail.

Capital Improvement Projects

- **\$564,000** for construction and repairs for the Hawai'i State Veterans Cemetery, Oahu.
- **\$500,000** for the replacement of the museum and the visitor center at the USS Arizona Memorial.
- **\$850,000** for Phase II improvements at the Oahu Veterans Center at Foster Village.
- **\$1,500,000** for construction for the adult day care facility at the Nisei Veterans Memorial Center, Maui.
- **\$4,400,000** for a specially designed complex for soldiers, airmen, veterans and retirees, including an expanded PX, commissary and office for veterans affairs in the Keaukaha Joint Military Center, Hawai'i.
- **\$18,228,000** for the construction of a long-term veterans care home in Hilo Medical Center, Hawai'i.

Housing Omnibus Bill

Creates more affordable rental housing; establishes homeless programs; provide incentives for private developers to build affordable housing projects. Makes administrative changes to various state housing programs.

Transportation

Public Transit; County Surcharge on State Tax

Authorizes the counties the option to establish a surcharge of up to 0.5 percent on State general excise and use taxes by the adoption of an ordinance no later than December 31, 2005.

Monies from said surcharge would be used for operating and capital costs of a locally preferred alternative for a mass transit project in counties with a population greater than 500,000 for public transportation and roadway needs for counties with less than 500,000 people.

Driver Licensing; Provisional Licenses; Persons Under 18

Creates a provisional driver's license between the permit and full license stages for those under 18; puts restrictions on the hours and number of hours for those with provisional licenses; sunsets provisional licenses in five years.

Traffic Offenses; Pedestrian in Crosswalks

Requires drivers of a vehicle to stop and yield the right-of-way to a pedestrian crossing the roadway within a crosswalk when the pedestrian is upon the half of the roadway upon which the vehicle is traveling or when the pedestrian is approaching so closely from the opposite half of the roadway as to be in danger.

Employment

Public Works; Small Business Set-Asides

Requires the State's Procurement Policy Board to establish rules to promote opportunities for small businesses on Hawai'i state and county contracts, including procedures to set aside smaller contracts for award to small businesses and requiring that the use of small businesses as subcontractors on larger contracts be considered in evaluating which larger contractors receive awards.

Minimum Wage

Raises the minimum wage to \$6.75 effective January 1, 2006, and to \$7.25 effective January 1, 2007.

Voluntary Employees' Beneficiary Association Trusts

Authorizes and sets forth the requirements for the establishment of a voluntary employees' beneficiary association (VEBA) trust by public employee organizations to provide health benefits for its members. Establishes a VEBA trust three-year pilot program to allow for the analysis of the costs and benefits of a VEBA trust against those of the Hawai'i Employer-Union Trust Fund.

Campaign Spending

Makes numerous changes to campaign spending statutes, including requiring all candidates to file electronically, prohibiting contributions from government contractors, and increasing the criminal penalty for falsifying information in campaign spending reports.

Crime

Sex Offender Registry

Expands public access requirements on information about convicted sex offenders or those who commit crimes against children. The state will no longer have to go through a court hearing before posting information about sex offenders on a state website.

Pseudoephedrine

Limits the retail sale of pseudoephedrine products (a key ingredient in the manufacturing of "ice") without a prescription to no more than three packages or not more than nine grams per transaction.

Sustainability

Legacy Lands

Allocates a higher percentage of the conveyance tax to the Rental Housing Trust Fund and allocates 10 percent of the tax to a new Land Conservation Fund to preserve pristine and open areas. Increases the conveyance tax paid on real estate transactions over \$600,000.

Education

Public School Teacher Shortage

Implement various strategies to promote teacher retention and recruitment. Some of highlights are:

- Establishes the Hawai'i Teacher Cadet Program for high school students
- Requires the Department of Education (DOE) to establish policies to enable newly hired employees to receive their 1st paycheck in a timely manner
- Requires the University of Hawai'i to review its admission policies for the College of Education and increase full time equivalent teacher education faculty positions by an additional five positions each year until FY 2014-2015
- Establishes a statewide Teacher Induction Program to ensure that a certain new teacher-to-mentor ratio that all mentors are qualified to work with newly hired teachers. This program is available to every newly hired teacher
- Facilitates the licensing of teachers entering DOE
 - *Requires the Hawai'i Teacher Standards Board to clarify the requirements, on a state-by-state basis, for out-of-state licensed teachers to obtain a license in Hawai'i
 - *Pursues full teacher license reciprocity with the mid-Atlantic states, California, Colorado, Illinois, Michigan, New York, Oregon and Washington
 - *Develops a plan to accept teachers from any state as long as they have completed state-approved teacher education programs and pass relevant Hawai'i teacher examinations or their equivalent.

Substitute Teachers

Sets daily pay rates for substitute teachers of \$119.80 for those without a bachelor's degree, \$130 for those with a bachelor's degree and \$140 for DOE teachers or those who are licensed or highly qualified.

Charter Schools

Clarifies aspects of Hawai'i's charter school laws. Establishes a more equitable basis of funding for charter schools; creates rigorous standards for the chartering of additional new century charter schools; creates a task force to identify and recommend to the 2006 Legislature revisions to the existing charter school law.

Early Childhood Education

- Proposes an overall plan to increase access
- Develop plans and identify resources needed to improve the quality and services
- Design proposals to support the professional development of staff
- Creates an implementation plan to motivate and promote the value of and participation
- Establishes and funds a two-year pilot program to provide universal access for families in critical need, as determined by the Department of Human Services (DHS).

Asbestos

Requires the DOE to ensure that asbestos testing is conducted prior to any renovations or painting of school facilities at all schools, except charter schools.

School Community Council

Clarifies the councils' duties by requiring them to ensure that the school's academic and financial plans are consistent with the educational accountability system.

DOE Appropriation

Appropriates funds to subsidize DOE information systems projects, provide for additional support personnel and training and to continue the implementation of Act 51.

Substance Abuse

Clarifies requirements for student drug abuse assessment referrals. Establishes task force to study process by which students are referred for substance abuse assessment and treatment.

Emergency Appropriation; Autism Spectrum Disorder

Provides an emergency appropriation from FY 2005 general funds of \$11,672,564 to pay for services to autistic children. Also pay for increased costs of school services provided to Felix Consent Decree children who are not able to participate in classroom-based activities.

UNIVERSITY OF HAWAII

Emergency Appropriation for Flood Losses

Makes an emergency appropriation of \$47 million for losses incurred by the UH Manoa as a result of the October 30, 2004 flood.

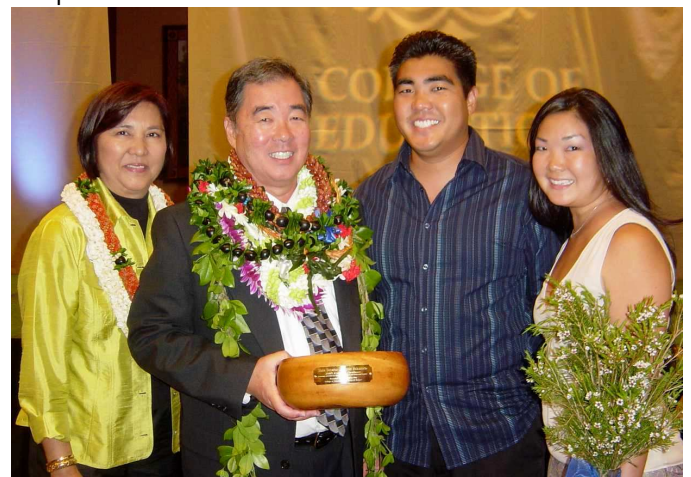
Constitutional Amendment; UH Board of Regents (BOR)

(Ballot in 2006 election)

Modify the appointment process of the Board of Regents - require the BOR to be selected from a pool of qualified candidates presented to the Governor by a Candidate Advisory Council.

UH Revenue Bonds

Authorizes \$100 million dollars in revenue bonds for the maintenance and construction of new housing at UH Manoa and the repair of current student housing units on all campuses.

We are working diligently to reduce the \$440,000,000 Repair and Maintenance backlog and improve our school facilities. Below are the school improvement projects by complex. For Aiea and Farrington complex, only a partial list is included. School projects with no dollar amount are less than \$100,000.

Moanalua Complex

- ✓ **Moanalua Elem** – \$292,000 classroom renovation, \$143,000 replace both A/C units, replace bell system, replace classroom furniture
- ✓ **Moanalua High** – \$114,000 reroofing, replace walkway lights, replace scoreboard, repair bleachers, replace bleacher motor, replace gym lamps, replace stadium lamps, replace classroom furniture, repair/repaint exterior, install hose bibs, termite tent treatment, renew sentricon
- ✓ **Moanalua Middle** – replace gas line valves, replace transformer, add F/A bell, replace classroom furniture, replace B & G PE lockers
- ✓ **Red Hill Elem** – air conditioning upgrades \$165,000 (**Legislature funded**), \$258,000 classroom renovation, drainage improvements, replace bell system, renew sentricon, replace classroom furniture
- ✓ **Salt Lake Elem** – \$800,000 renovation of Building F (**Legislature funded**), \$161,000 fire alarm upgrade, replace grease trap, replace classroom furniture
- ✓ **Shafter Elem** – exterior waterproofing, replace grease trap, campus ant control, replace classroom furniture

Radford Complex

- ✓ **Aliamanu Elem** – \$5,017,000 classroom renovation, \$161,000 fire alarm upgrade, reroofing, fence & C-gates, improve area lighting
- ✓ **Aliamanu Middle** – \$300,000 replace water lines, \$142,000 for reroofing, renew sentricon
- ✓ **Hickam Elem** – \$7,670,000 new or expanded library-administration building (**Legislature funded**), \$355,000 classroom renovation, \$107,000 replace bell system, repair concrete walkway, reroofing, replace classroom furniture
- ✓ **Makalapa Elem** – \$161,000 replace fire alarm system, replace exhaust fans, replace R/R partitions, campus ant control
- ✓ **Mokulele Elem** – \$275,000 classroom renovation, \$108,000 reroofing, \$107,000 replace water lines, replace classroom furniture
- ✓ **Nimitz Elem** – \$293,000 classroom renovation, \$107,000 regrade playground, repair/replace chain link fence, campus structural evaluation, campus ant control, replace classroom furniture
- ✓ **Pearl Harbor Elem** – \$161,000 replace waterlines (phase 2), \$116,000 replace bell system
- ✓ **Pearl Harbor Kai Elem** – \$167,000 reroofing, resurface playcourt, replace classroom furniture, add electric circuits
- ✓ **Radford High** – \$408,000 fire alarm upgrade, \$184,000 replace A/C units, reroofing, replace stadium lamps, replace gym lamps, replace classroom furniture

Aiea Complex (partial list)

- ✓ **Aiea Elem** – \$1,200,000 air-conditioning upgrades (**Legislature funded**), replace waterlines, replace dumbwaiter, campus wide sentricon, replace classroom furniture, install air-conditioning systems for certain classrooms in buildings A, B, C, and E
- ✓ **Aiea Inter** – \$650,000 electrical upgrade, \$400,000 portable classrooms, \$100,000 bus stop overhang (**Legislature funded**), replace air conditioning unit, replace classroom furniture, renew sentricon
- ✓ **Aiea High** – replace/reline sewer, replace locker room lights, repair/paint bleachers, bleacher hand rails, replace gym lamps, replace stadium lamps, replace campus furniture, field maintenance
- ✓ **Alvah Scott Elem** – \$141,000 replace bell system, replace irrigation system

Farrington Complex (partial list)

- ✓ **Farrington High** – \$685,000 all-weather track (**Legislature funded**), \$536,000 reroof/replace soffit, reroof spray booth, campus furniture, remove trailers, replace exhaust fans, install air conditioning in building O, renovate health room
- ✓ **Kalakaua Middle** – \$2,181,000 repairs, improvements to school walls (**Legislature funded**), \$141,000 reroofing, replace A/C equipment, campus furniture
- ✓ **Puuahale Elem** – \$225,000 for covered walkways (**Legislature funded**), \$135,000 renovate restroom (phase 1), renew campus sentricon



Act 51 Update

EMPOWERMENT

Weighted Student Formula

The law mandated a Committee on Weights to determine a weighted student formula- a way to distribute resources to schools based on student enrollment and student characteristics. Funding on student need is more equitable than one-size fits all mandates. Of the 252 Hawai'i schools subject to the funding change, 137 are projected to get less money under the formula, and 115 would get more, according to data compiled by the state DOE. The formula change must be approved by the full Board of Education (BOE), scheduled for an August 18 final vote.

STREAMLINING

Single School Calendar

On July 12, the BOE committee recommended the board approval of a draft 2006-07 school calendar. The 1-3-2 model for the proposed calendar (one-week recess, three-week winter recess, and two-week spring recess) was approved by the BOE on June 9. The year will end on June 7 for students, who will have a six-week summer break. Charter and multitrack schools are exempt from the single-calendar requirement. The calendar is expected to be presented for final approval by the full BOE on September 1.

Transfer to the DOE

Interagency Working Group (IWG) was mandated to develop comprehensive plans for transferring certain rights, powers, functions, duties, and resources – including positions by positions numbers, from six other state agencies to the DOE over two years. On July 1, DOE welcomed nearly 200 Department of Accounting & General Services (DAGS) employees. DOE will be responsible for all of the personnel, repair and maintenance (R&M) and capital improvement projects (CIP) formerly under Department of Human Resources and Development (DHRD) and DAGS.

ACCOUNTABILITY

Principals

Convert principal positions to a 12-month term of service, including proposed salary schedules. The 2005 Legislature approved funding a 12-month term of service for all principals, beginning July 1, 2005.

Announcements & Congratulations

- **Hawaii 3R's** is a non-profit organization with a mission to tackle the backlog of repair and maintenance projects in Hawaii's public school facilities by leveraging available funds with volunteer support. Two schools in our district have been awarded grants from Hawaii 3R's. **Aliamanu Elementary School** has been awarded \$34,400 to resurface their playground. **Aliamanu Middle School** has been awarded \$50,000 to resurface their basketball court.

Community News

- US Senator Daniel K. Inouye announced that the Senate had passed two funding bills that include projects in Hawai'i. Highlights are:
 - *\$100,000 for the reconnaissance phase of the **Moanalua Stream Flood Damage Reduction Project**. Moanalua's stream banks overflow periodically causing extensive damages to commercial and residential properties.
 - *\$1.69 million to begin the planning for the replacement of the **USS Arizona Memorial Visitor Center**.
- The US Army Corps of Engineers will remove 13 large boulders from **Moanalua Valley hillsides** (Ala Aolani Street and Ala Aolua Loop) and install landslide-prevention netting in a \$1.4 million project that started on July 25.
- July 25 also signaled the start date on **improvement projects for Puuloa Road**. Day work hours are 7 AM to 3:30PM. Actual lane closures can begin at 8:30AM. Night work hours are from 7:30 PM to 5:30 AM (Sunday night through Friday morning) only for work at the Puuloa Road / Salt Lake Boulevard / Pukoloa Street Intersection. Night work at those intersections will start early next year. Pukoloa Street will be closed during certain phasing of work and detour routes will also be implemented.
- The Legislature has set aside \$3 million in the budget for the purchase of 3,700 acres of land in **Moanalua Valley**. Damon Estate is in the process of selling Moanalua Valley, which is the only undeveloped valley in central Oahu.
- The maintenance dredging of Phase One & Two of **Salt Lake Waterway** have been completed. The Legislature allocated \$400,000 in the budget to help in the continued efforts. The final area along Ala Liliko'i Street to Ala Pu'umalu Park remains to be cleaned. The sediment run-off analysis study of the Waterway below the Aliamanu Military crater needs to be completed before Phase Three work begins.

In our last district mailing (March 2005), we included a legislative survey. Thank you to all of you who participated. Below are some of the results of the 2005 Legislative Survey:

Transportation

69% responded that they would be willing to pay a 1% increase of the GET in order to help fund a portion of mass transit.

31% responded that there is currently no need to create a more comprehensive mass transit system to address the traffic congestion in the state.

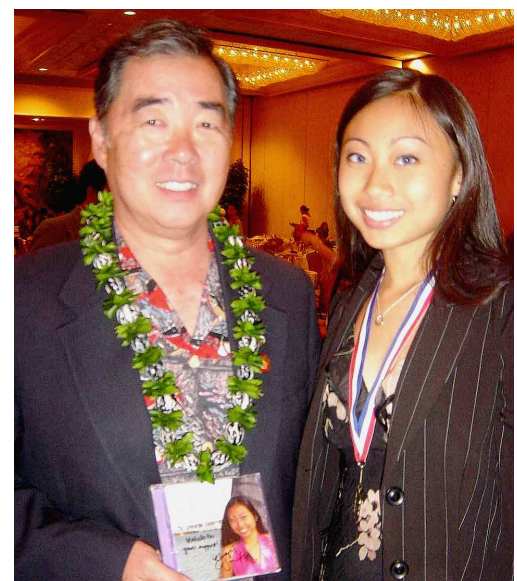
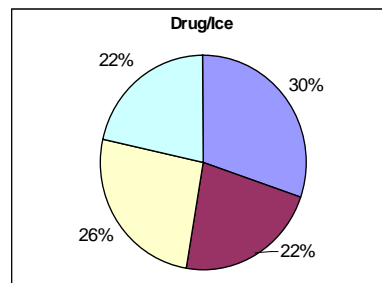
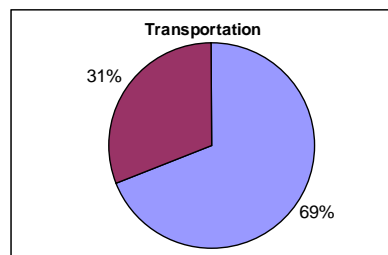
Drug/Ice

30% responded that support needs to be increased for rigorous law enforcement efforts to increase the number of incarcerations.

26% responded that access should be restricted to nonprescription medications that are potential ingredients for Ice by placing them behind the pharmacy counter.

22% responded that successful treatment programs need to be more aggressively supported & expanded.

22% responded that it should be made easier for landlords to evict tenants for unlawfully possessing illegal drugs.
