DECISION¹

On March 12, 2008, the parties to the above captioned case filed a Stipulation memorializing their agreement as to the appropriate amount of compensation in this case. Petitioner alleged that Daniel sustained an autoimmune disorder after receiving hepatitis B and tetanus-diphtheria vaccine. Respondent denies that Daniel's autoimmune disorder was vaccine-related. Nonetheless, the parties agreed informally to resolve this matter.

The court hereby **adopts** the parties' said Stipulation, attached hereto, and awards compensation in the amount and on the terms set forth therein. Specifically, petitioner is awarded a lump sum of \$75,000 in the form of a check payable to petitioner as guardian/conservator of Daniel's estate. The Clerk of the Court is directed to enter judgment

STIPULATION

The parties hereby stipulate to the following matters:

1. On behalf of her son, Daniel Rutledge ("Daniel"), petitioner filed a petition for vaccine compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. § 300aa-10 to 34 (the "Vaccine Program"). The petition seeks compensation for injuries allegedly related to Daniel's receipt of the vaccinations including hepatitis B ("hep B") and tetanus-diphtheria vaccine ("Td"), which vaccines are contained in the Vaccine Injury Table (the "Table"), 42 U.S.C. § 100.3 (a) (I) and (a) (VIII).

2. Daniel received hep B immunizations on April 4, 2003 and August 5, 2003. He received a Td immunization on July 21, 2003.

3. The vaccines were administered within the United States.

4. Petitioner alleges that Daniel sustained an autoimmune disorder as a result of the vaccinations he received.

5. Petitioner represents that there has been no prior award or settlement of a civil action for damages on behalf of Daniel as a result of his condition.

6. Respondent denies that Daniel suffers from an autoimmune condition as a result of the vaccinations he received on April 4, 2003, August 5, 2003 and July 21, 2003, and denies that his current medical condition is a sequelae of a vaccine related-injury.

7. Maintaining their above-stated positions, the parties nevertheless now agree that the issues between them shall be settled and that a decision should be entered awarding the compensation described in paragraph 8 of this Stipulation.

8. As soon as practicable after an entry of judgment reflecting a decision consistent with the terms of this Stipulation, and after petitioner has filed an election to receive compensation pursuant to 42 U.S.C. § 300aa-21(a)(1), the Secretary of Health and Human Services will issue the following vaccine compensation payment:

A lump sum of \$75,000.00 in the form of a check payable to petitioner as guardian/conservator of Daniel's estate. This amount represents compensation for all damages that would be available under 42 U.S.C. §300aa-15(a).

9. As soon as practicable after the entry of judgment on entitlement in this case, and after petitioner has filed both a proper and timely election to receive compensation pursuant to 42 U.S.C. § 300aa-21(a)(1), and an application, the parties will

submit to further proceedings before the special master to award reasonable attorneys' fees and costs incurred in proceeding upon this petition.

10. The payment made pursuant to paragraph 8 and any amounts awarded pursuant to paragraph 9 of this Stipulation will be made in accordance with 42 U.S.C. § 300aa-15(i), subject to the availability of sufficient statutory funds.

11. The parties and their attorneys further agree and stipulate that, except for any award for attorneys' fees and litigation costs, the money provided pursuant to this Stipulation will be used solely for the benefit of Daniel as contemplated by a strict construction of 42 U.S.C. § 300aa-15(a) and (d), and subject to the conditions of 42 U.S.C. § 300aa-15(g) and (h).

12. Petitioner represents that she presently is, or within 90 days of the date of judgment will become, duly authorized to serve as guardian/conservator of Daniel's estate under the laws of the State of Florida. No payments pursuant to this Stipulation shall be made until petitioner provides the Secretary with documentation establishing her appointment as guardian/conservator of Daniel's estate. If petitioner is not authorized by a court of competent jurisdiction to serve as guardian/conservator of the estate of Daniel Rutledge at the time a payment pursuant to this Stipulation is to be made, any such payment shall be paid to the party or parties appointed by a

court of competent jurisdiction to serve as guardian of the estate of Daniel Rutledge upon submission of written documentation of such appointment to the Secretary.

13. In return for the payments described in paragraphs 8 and 9, petitioner, in her individual capacity and as legal representative of Daniel, on behalf of herself, Daniel, and his heirs, executors, administrators, successors or assigns, does forever and fully expressly release, acquit and discharge the Secretary of Health and Human Services and the United States of America from any and all actions, causes of action, agreements, judgments, claims, damages, loss of services, expenses and all demands of whatever kind or nature on account of, or in any way growing out of, any and all known or unknown personal injuries to or death of Daniel resulting from, or alleged to have resulted from, the hep B and Td vaccinations administered on April 4, 2003, August 5, 2003 and July 21, 2003, as alleged by petitioner in a petition for vaccine compensation filed on or about February 8, 2006, in the United States Court of Federal Claims as petition No.06-0100V.

14. If Daniel should die prior to receiving the payment described in paragraph 8, this agreement shall be considered voidable upon proper notice to the Court on behalf of either or both of the parties.

15. If the special master fails to issue a decision in

complete conformity with the terms of this Stipulation or if the Court of Federal Claims fails to enter judgment in conformity with a decision that is in complete conformity with the terms of this Stipulation, then the parties' settlement and this Stipulation shall be null and void at the sole discretion of either party.


16. This Stipulation expresses a full and complete settlement of liability and damages claimed under the National Childhood Vaccine Injury Act of 1986, as amended, except as otherwise noted in paragraph 9 above. There is absolutely no agreement on the part of the parties hereto to make any payment or to do any act or thing other than is herein expressly stated and clearly agreed to.

17. All rights and obligations of petitioner hereunder shall apply equally to petitioner's successors and assigns as legal representatives of Daniel Rutledge.


