## INTERIM ATTORNEY'S FEES AND COSTS DECISION<sup>1</sup>

## GOLKIEWICZ, Chief Special Master.

Petitioners filed an Interim Petition for Attorney's Fees and Costs on May 1, 2008. On May 14, 2008, the parties contacted the Court via telephone. Respondent's counsel indicated she had reviewed petitioners' Interim Petition for Attorney's Fees and Costs and had no objections to petitioners' request for fees and costs, with the exception that the total filing fee paid to the court by counsel should reflect \$250.00 and not \$350.00. Petitioners' counsel agreed \$250.00 was the correct filing fee paid<sup>2</sup> and agreed to reduce his request by \$100.00 to a total of **\$67,265.31**. Respondent's counsel indicated she had no objection to petitioners' reduced request for

attorney's fees and other litigation costs.

Petitioners are entitled to an award of interim attorney's fees and costs. The undersigned determines that there is no just reason to delay the entry of judgment for an award of interim attorney's fees and costs. See Avera v. Secretary of HHS, 515 F.3d 1343, 1352 (Fed. Cir. 2008). After reviewing the request, the court awards \$67,265.31 in interim attorney's fees and other litigation costs, made payable jointly to petitioners and their attorney. The court thanks the parties for their cooperative efforts in resolving this matter. The Clerk shall enter judgment immediately.<sup>3</sup>
