



Order on Respondent Leanne G. Spencer's Motion to Compel Production of Documents Improperly Withheld as Privileged

On July 30, 2007, Respondent Leanne G. Spencer filed the above described motion, and OFHEO filed its Opposition on August 31, 2007.¹ Having closely reviewed the filings, Respondent Spencer's Motion is DENIED.² The parties should consult the practice employed in the other OFHEO matter, (which was settled and about which the parties are quite familiar), for the procedure employed in resolving disputes over privilege logs and how the Court went about addressing those disputes.³


