12 13 14 15	SECTION 1. The Bernalillo County Code is hereby amended to include the following new language in Chapter 42, Division 11, replacing the previous Chapter 42, Division 11, Individual Water Supply Systems, which is hereby repealed:
16	CHAPTER 42, DIVISION 11 WATER WELLS
17	Sec. 42-541. Purpose
18	The Board of County Commissioners has determined that potential sources of
19	contamination exist which may threaten the quality of ground water in Bernalillo County
20	and consequently, the health, safety, commerce, public services, property, and the general
21	welfare of the public. These potential sources of contamination are created by a
22	cumulative effect of human influence and/or natural activities taking place within
23	sufficient proximity to Bernalillo County's ground water supply as to pose a threat of
24	contamination. The objective of this Ordinance is to provide minimum requirements for
25	the construction, modification, and abandonment of private, multiple household, public,
26	and monitoring wells, and thereby provide protection of the ground water within the
27	unincorporated areas of Bernalillo County.
28	Sec. 42-542. Applicability
29	This Ordinance shall apply to any person or entity desiring to engage in construction
30	or use of one or more wells for ground water within the unincorporated areas of
31	Bernalillo County, including the construction of wells for monitoring purposes. The
32	County may order that wells be abandoned if they do not comply with any provision of
33	this Ordinance. In those instances where this Ordinance does not address procedures and

34 practices of well construction, modification, and abandonment, the Rules and Regulations

of the OSE, the "Manual of Water Well Construction Practices," (NGWA (1998) or most

3 Sec. 42-543. Definitions

- 4 "Abandoned Well" means a well which will no longer be used or which is in a state of
- 5 disrepair such that it cannot be rehabilitated for its intended purpose or monitoring and
- 6 observation.
- 7 "Abandonment" means proper well sealing to remove all physical and contaminant
- 8 hazard and to best simulate the pre-existing hydrogeologic conditions.
- 9 *"Annulus"* means the space within the borehole not occupied by the well casing.
- 10 *"Arroyo"* means any ephemeral watercourse that only carries water during a storm event.
- 11 *"Borehole"* means any hole drilled into the ground for the purpose of extracting ground
- 12 water.
- 13 "Coliform" means a group of related bacteria whose presence in water may indicate
- 14 contamination by disease-causing microorganisms.
- 15 "Construction" means well construction, but is not limited to, the installation of new or
- 16 replacement structures, equipment or pipe for the extraction of ground water.
- *"Contaminant"* means any physical, chemical, biological, or radiological substance that
 may adversely affect water quality.
- 19 *"Contamination"* is the introduction into ground water of any contaminant that will
- 20 affect water quality.
- *"Contractor"* means a licensed, qualified person who drills, completes, or conducts work
 on water supply systems and/or wells.
- *"County"* means the Bernalillo County Commission, Bernalillo County Manager, and/or
 representative thereof.
- 25 "Department Director" means the Director of the Building, Planning, Zoning, and
- 26 Environmental Health Department.

1 "Disinfectant" means any substance including, but not limited to, chlorine, chlorine

2 dioxide, chloramines, and ozone by which water is treated in any part of the treatment or

3 distribution process, that is intended to kill or inactivate pathogenic microorganisms.

4 "Domestic purposes" means use of water for human consumption including, but not

5 limited to, the processing and preparation of food for human consumption; for use in

6 washing and rinsing those utensils and equipment used in the preparation, processing or

7 consumption of food; for use in swimming pools; for bathing and other personal use, for

8 the watering of livestock; or irrigation. This may include residential, commercial, or

9 institutional uses.

10 *"Driven Well"* means a well where the casing is pushed into the ground rather than set

11 into a drilled hole.

"Dry Hole" means a well that will not yield sufficient quantities of water for the intendeduse.

14 *"EPA"* means the United States Environmental Protection Agency.

15 *"Final Approval"* means the approval granted when all inspections, including a final

16 inspection, have been approved.

17 *"Floodplain"* means the floodplain defined by the Federal Emergency Management

18 Agency Floodplain Maps.

"Ground Water" means water in a saturated zone or stratum beneath the surface of landor water.

21 "Ground-Water Protection Policy and Action Plan" (GPPAP) is the adopted plan by

22 Bernalillo County and the City of Albuquerque defining the need for ground water

23 protection initiatives.

"Individual Well" means a well that supplies water and associated piping that serves asingle lot or household.

26 "Legal Existing Well" means a well that was previously permitted and approved under

27 the requirements at the time of construction or modification. Wells constructed or

28 modified on or after December 1987 must have been permitted, inspected, and approved

- 1 by the County to be considered a legal existing well. A well that was constructed or
- 2 modified before December 1987 must hold an OSE permit that is dated from the time of
- 3 construction or modification. Prebasin wells are considered legal existing wells with
- 4 appropriate documentation.
- 5 "Maximum Contaminant Level" means the maximum permissible level of a contaminant
- 6 in ground water as defined by NMED.
- 7 *"Modification"* means the repair or deepening of a well, the establishment of an
- 8 additional connection to a structure or lot not previously connected to a multiple
- 9 household well, the conversion of an individual well to a multiple household well, or the
- 10 installation of some means to treat contaminated water. This excludes the replacement of
- 11 existing mechanical and electrical parts.
- 12 *"Monitoring Well"* means a well that is used to obtain water quality samples or measure
- 13 groundwater levels.
- 14 *"Multiple Household Well"* means a well and associated piping that serves more
- 15 than one lot and/or household but does not qualify as a public water supply
- 16 system.
- 17 *"NMED"* means the New Mexico Environment Department.
- 18 "OSE" means the New Mexico Office of the State Engineer or equivalent
- 19 regulatory authority.
- 20 "Owner" means the person or entity responsible for the well. If there is no
- 21 designated well owner, the property owner is responsible for the well.
- 22 "Permit Application" means a form supplied by the County for the purpose of
- 23 requesting a well permit and any supporting documents as required by the
- 24 County.
- 25 "Person" means any individual, public or private corporation, association, trust,
- 26 estate, political subdivision or agency, or any other legal entity or their legal
- 27 representatives, agents, or assigned others.

- 1 *"Pollution"* means the presence in water of enough harmful or objectionable
- 2 material to damage or degrade the water quality or pose a threat to public health.
- 3 "Prebasin Well" means a well that was drilled prior to the OSE having
- 4 jurisdiction over the ground water the well utilizes. Prebasin wells may be
- 5 declared with the OSE.
- 6 "Public Well" means a well for the provision to the public of piped water
- 7 for human consumption if such system has at least fifteen (15) service
- 8 connections or services an average of twenty-five (25) individuals on a
- 9 regular basis.
- 10 "Surface Water" means water that is present, flowing, and located on the surface
- 11 of the earth.
- 12 *"Use"* means the withdrawal of water from a well using manual or mechanical
- 13 means.
- 14 *"Water Quality"* means the physical, chemical, biological, and aesthetic properties
- 15 of water.
- 16 *"WQCC"* means the Water Quality Control Commission.
- 17 "Well Driller" means a licensed, qualified party who drills, completes, and/or
- 18 conducts work on wells.
- 19 *"Well"* means an excavation or opening into the ground made by digging, boring,
- 20 drilling, driving, or other methods, the purpose of which is to obtain ground water
- 21 for use, and/or monitoring ground water levels or quality.
- 22 *"Wellhead"* means the area immediately surrounding the top of a well, or the top of a
- 23 well casing.
- 24 *"Wellhead Protection"* means the combination of land-use planning and well
- 25 construction techniques and abandonment standards that protect and manage the ground
- 26 water resources of Bernalillo County.

Sec. 42-544. Use Requirements for Individual Wells

A. No person or entity shall construct, install, modify, or use an individual well unless it 2 3 is constructed, permitted, and maintained in accordance with the provisions of this Ordinance. 4 B. No person shall use an individual well that does not meet the construction 5 requirements of this Ordinance. 6 7 C. No person shall use an individual well that produces water that exceeds the maximum 8 contaminant levels allowed. D. No person shall use an individual well that does not meet the conditions placed by the 9 OSE. 10 E. Any new or modified well must be tested and meet water quality standards for 11 12 parameters as determined by the County before final approval will be granted. Water sample collection, analysis, and analytical costs are the responsibility of the owner. 13 14 The analysis should include, but is not limited to, the following: total coliform, total Kjeldahl nitrogen (TKN), ammonia, nitrate, nitrite, sodium, potassium, calcium, 15 16 magnesium, chlorine, bicarbonate, total dissolved solids, pH, and sulfate. Additional water sampling parameters may be required based on site conditions. 17 18 F. While individual well users are strongly encouraged to connect to municipal, Authority, or private regulated systems when those systems become available, any 19 user of an individual well that meets all requirements of this Ordinance is not required 20 to connect to a pubic water supply system by this Ordinance. Well users in the 21 Valley areas are encouraged to continue to use their individual wells for irrigation 22 23 purposes. Sec. 42-545. Site Requirements for Individual Wells 24 A. The location of the well on the site shall not be located in Zones A, AE, AH, or AO as 25 defined by Federal Emergency Management Agency Flood Hazard Maps. The well 26 location shall be upgradient from known sources of pollution and contamination that 27

may affect the water quality from the well. Final grading shall be done in a way that

- 6 B. Lots that are zoned commercial or manufacturing, or lots with special use permits
- 7 allowing those purposes, shall meet setback distances two (2) times the distance
- 8 required for individual wells as shown on Table 1.

9 C. Wells cannot be located within the boundaries of an easement not designated for

- 10 access to the well.
- 11 D. The well shall be located so that it is accessible for maintenance.

12 Sec. 42-546. Construction Requirements for Individual Wells

13 A. Materials used in wells and boreholes shall be in good condition and conform to

14 industry standards acceptable to the County including those standards developed by

the American Water Works Association (AWWA), American Society for Testing
 Materials (ASTM) and National Groundwater Association (NGWA).
 B. All down-hole equipment shall be thoroughly cleaned prior to the start of drilling. No
 contaminated or untreated water shall be placed in a well or borehole during
 construction or abandonment.

6 C. Final grading shall be done in a way that drains storm water away from the wellhead.

D. A concrete pad, at least four (4) inches thick and extending at least three (3) feet from
the well casing on all sides, shall be built around the well casing on the surface. The
top of the concrete pad shall be graded to slope away from the well casing in all
directions. The top of the well casing shall extend a minimum of eighteen (18) inches
above the land surface.

12 E. All wells and boreholes shall be constructed to prevent contaminants from entering

13 the well or borehole from the ground surface or other aquifers. All wells shall be

14 constructed to prevent contamination from the ground surface by sealing the annular

15 space around the production casing or by enclosing the production casing with a

sealed surface casing. Seals shall extend to a minimum of twenty (20) feet below

17 ground surface. Seals must extend to the base of the concrete pad or to the base of

18 the pitless adapter, if used. All sealing operations required under this section shall be

19 performed in a manner specified by the County. Casings shall be centered in the

20 borehole so grout or other sealing materials are evenly spaced around the casing. The

22 F. Wells which encounter undesirable water at any depth shall have the well annulus

23 sealed to prevent the commingling of undesirable water with other water, or the loss

- 24 of water into undesirable water quality zones.

A. Prior to the construction, installation, modification, or abandonment of an

- 27 individual well, a permit must be obtained from the County. Failure to obtain
- a permit from the County prior to the construction or installation of a new

B. Any person seeking an individual well permit shall do so by filing a written permit 3 application with the County, accompanied by the applicable fee as determined by the 4 Fee Schedule as set by the Board of County Commissioners. The application, plans 5 and specifications, and other documentation submitted for review shall be clear, 6 7 legible, and of a permanent nature. The burden of proof that the well will meet all requirements of this Ordinance is the responsibility of the applicant. The County may 8 require that wells found to be in violation of the requirements of this Ordinance be 9 abandoned at the owner's expense. An individual well permit application shall not be 10 accepted until all information outlined below is provided. 11 12 1. The applicant's name, mailing address, telephone number, and signature; 2. The property owner's name, mailing address, and telephone number; 13 3. Authorization for the installation of the well by the property owner, if different 14 from the applicant; 15 16 4. The date of the application; 5. The site address, legal description, and the Uniform Property Code; 17 6. A scaled drawing with a minimum scale of one (1) inch is equal to twenty (20) 18 feet showing the following: 19 The proposed location of the well on the lot; 20 a. b. Drainage areas, Middle Rio Grande Conservancy District Ditches and 21 Albuquerque Metropolitan Arroyo Flood Control Authority flood control 22 areas within 100 feet of the well; 23 Proof of compliance with the minimum setbacks in Table 1. This may require 24 c. a depiction of properties beyond the lot boundaries. 25 Other wells currently in use or abandoned; d. 26 Road easements, utility easements (including those used for shared wells), and 27 e. road thoroughfares; 28

- Issued. If the County determines that the proposed design and installation,
 or the proposed modification of a well conforms with the pertinent
- 18 provisions of this Ordinance, the County shall issue a permit.
- Issued with conditions. If the County determines that the proposed design
 or the proposed modification of a well conforms with the pertinent
 provisions of this Ordinance only after specific conditions are followed, a
- permit may be issued. Final approval will not be granted unless all
 conditions are met.
- <u>Denied</u>. If, upon review, the proposed well design and installation, or the
 modification of an existing well does not meet the requirements of this
 Ordinance, the permit shall be denied. The County shall notify the
 applicant, in writing, the reasons for the denial. The permit application

shall become void after thirty (30) days from the date of the decision,

unless the applicant has appealed.
D. The County shall issue a decision within three (3) business days if the
applicant pays a permit rush fee as determined by the Fee Schedule as set by
the Board of County Commissioners.
E. The applicant may appeal the decision of the County within thirty (30) days of
the decision.

F. The County shall maintain a file of all individual well permit applications anddecisions.

10 G. Permits shall become void if the well is not constructed, installed, modified,

and final approval granted within one (1) year from the date of issuance of the

12 permit. Extensions, not to exceed one year, will be granted if the County

13 receives a written extension request prior to the expiration date of the permit.

14 H. Permits are not transferable from place to place.
