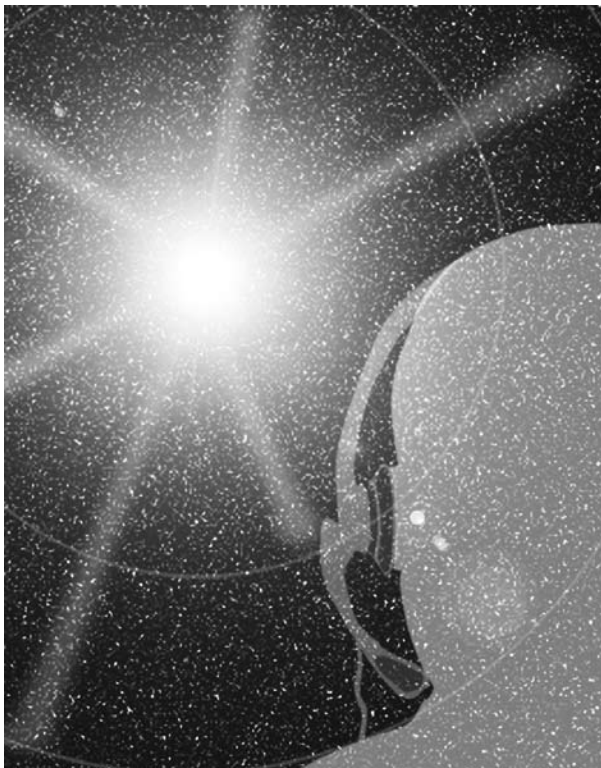
FOREWORD

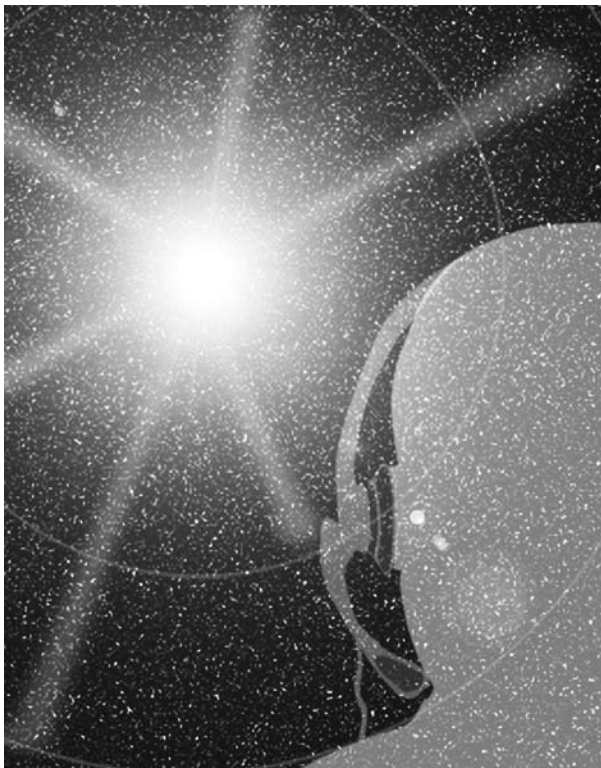

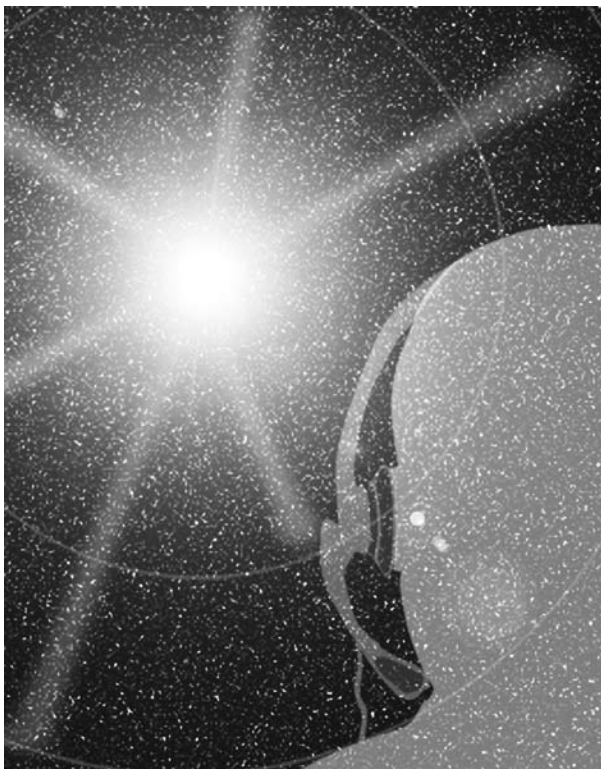
