To maximize America's capacity to support volunteerism, we will:

- » Support 75,000 Americans as AmeriCorps members who will mobilize more than 1.7 million volunteers;
- » Increase emphasis on leveraging community volunteers and building volunteer management capacity in all Corporation programs; and
- » Expand national participation in the Martin Luther King, Jr. Day of Service to engage new volunteers.

3 Student Service

To engage more students in service, through service-learning and other strategies, we will:

- » Support 1.3 million students in 1,500 service-learning programs;
- » Promote a nationwide recognition of the importance of service-learning as a core part of every young person's education; and
- » Increase focus on service-learning activities within science, technology, engineering, and math (STEM) disciplines.

2 Disadvantaged Youth

To address unmet needs of children and youth, and particularly those from disadvantaged circumstances, we will:

5 Disaster Relief

To support disaster preparedness and response, we will:

- » Train volunteer and donations management staff;
- » Provide teams of trained volunteers to assist in response for mass care, and housing and human services emergency support; and
- » Lead the coordination and management of unaffiliated volunteers on major disasters in partnership with other agencies and organizations.
