

Special Diabetes Program for Indians: Demonstration Projects Cardiovascular Disease Risk Reduction (CVD)

In 2004, Congress directed the Indian Health Service to launch the *Special Diabetes Program for Indians* Diabetes Prevention Demonstration Project and Healthy Heart Demonstration Project.

Thirty programs are focusing on cardiovascular disease risk reduction in American Indian and Alaska Native adults with diabetes.
