**SUMMARY**: Notice is hereby given that the U.S. International Trade Commission has determined to extend the deadline for determining whether to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 15) granting in part respondents' joint motion for summary determination of non-infringement of the asserted claims in United States Patent Nos. 5,517,628 ("the '628 patent") and 6,253,313 ("the '313 patent").

**SUPPLEMENTARY INFORMATION**: This investigation was instituted on January 9, 2006, based on a complaint filed by Biax Corporation ("Biax") of Boulder, Colorado. The complaint alleges violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital processors or digital processing systems, components thereof, or products containing the same by reason of infringement of various claims of United States Patent Nos. 5,021,945, 5,517,628, and 6,253,313. The complaint, as amended, names five respondents:

Philips Semiconductors B.V. of the Netherlands; Philips Semiconductors, Inc. of San Jose, California; Philips Consumer Electronics B.V. of the Netherlands; Philips Electronics North America Corp. of Atlanta, Georgia (collectively, "Philips"); and 2Wire, Inc. ("2Wire") of San Jose, California.

On October 4, 2006, the ALJ issued an ID (Order No. 15), granting in part respondents' joint motion for summary determination of non-infringement of the asserted claims in the '628 patent and the '313 patent. On October 12, 2006, Biax and the investigative attorney ("IA") filed petitions for review of the ALJ's ID. Philips and 2Wire filed a joint opposition to Biax's and the IA's petitions for review on October 19, 2006. The IA also filed a reply to Biax's petition for review on October 19, 2006.

The Commission has determined to extend the deadline for determining whether to review the subject ID by fourteen (14) days to November 20, 2006.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42(h) of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42(h)).
