SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 34) issued by the presiding administrative law judge ("ALJ") terminating the above-captioned investigation as to certain patent claims.

SUPPLEMENTARY INFORMATION: This investigation was instituted on June 29, 2006, based on a complaint filed by Samsung Telecommunications America, LLP and Samsung Electronics Co., Ltd. ("Samsung"). The complaint alleged violations of Section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States and the sale of certain wireless communications equipment, articles therein, and products containing the same by

reason of infringement of certain claims of U.S. Patent Nos. 6,598,202 ("the '202 patent"); 6,882,636 ("the '636 patent"); 6,154,652 ("the '652 patent"); 6,920,331 ("the '331 patent"); 6,421,353 ("the '353 patent"); 6,920,602 ("the '602 patent"); and 6,928,604 ("the '604 patent"). The complaint named four respondents: Ericsson, Inc.; Telefonaktiebolaget LM Ericsson; Sony Ericsson Mobile Communications AB; and Sony Ericsson Mobile Communications (USA) Inc.

On March 21, 2007, the presiding administrative law judge (Judge Luckern) issued an ID granting an unopposed motion by Samsung to terminate the investigation as to the following claims: claims 3 and 8-10 of the '353 patent; claims 1, 2, 8-10, and 13-15 of the '202 patent; claims 3, 16, 19, 22, 24, 25, and 28 of the '636 patent; claims 4, 16, 27, 29, 31, 34, 36, 39, 41, 45, and 48 of the '652 patent; claims 3, 11, 22, 25, 29, and 34 of the '331 patent; claims 2, 12, and 23 of the '602 patent; and claims 4, 6, 12, 19, 20, and 28 of the '604 patent. No petitions for review of the ID were filed. The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
