This session is a continuation of the groundwork established at the disaster services conference in Dallas, TX. Attendees will become familiar with the Office of Emergency Management and be able to engage a guest panel of federal, state, and local emergency management agencies as well as participate in affinity group discussions. Attendees will include state commission EDs, AmeriCorps National program directors, AmeriCorps NCCC regional directors, and area managers from the Office of Field Liaison.

Participants will acquire a better understanding of CNCS' vision for its fifth strategic initiative, as well as how national deployment and reimbursement processes work, and also how to create partnerships to advance their involvement in local and statewide disaster services activities in all four phases of disaster: preparedness, response, recovery, and mitigation.

1. Session: <u>Building a Mentoring Community for Youth Aging Out of Foster Care</u>

This session will introduce participants to the Foster Youth Mentoring Campaign, a cross-agency initiative of the Federal Mentoring Council, to engage mentors for the some 20,000 youth who age-out of the foster care system annually. Participants will learn the plight of youth aging-out of foster care, hear about best practices and model programs that serve this population, and explore ways they can get involved in this campaign in their state as it rolls out in 2008.

2. Session: Emerging State Policies and Practices for Civic Engagement of
