Please find attached the Direct Patient Care Statistical Report for the first half of fiscal year 2005 ending March 31, 2005. This report summarizes patient activity for each inpatient facility in the Phoenix Area by month beginning with October, the first month of the fiscal year. Only inpatient statistics for adults/pediatrics and newborns are included.

On the right side of each page appear the current fiscal year-to-date counts (a), the full year counts for the prior fiscal year (b), the *average* count for the same period of the prior year (c), and lastly, the percent change from the same period of last year. This last column, "Percent Change", can identify one or more areas of interest: e.g. changes in the workload, problems with data entry or problems with data processing. A quick review of this column can help to identify areas that may need special attention.
