

MINOR CONSENT, INDEMNIFICATION AND RELEASE AGREEMENT AND  
AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS AND VOICE

I understand that Outdoor Recreation Adventures are programs (collectively, the “Program”) of the City Of Albuquerque acting through its Parks and Recreation Department for youth. The City of Albuquerque will not be able to operate the Program if its limited resources are threatened by lawsuits. The City of Albuquerque’s ability to provide the Program depends on a certain amount of accommodation and understanding by its participants. I THEREFORE AGREE TO ASSUME THE RESPONSIBILITY FOR MY CHILD’S PARTICIPATION IN THE PROGRAM, AS REFLECTED IN THIS AGREEMENT.

FOR AND IN CONSIDERATION of my child’s participation in and use of any of the premises, facilities and equipment of any Program, to the fullest extent permitted by applicable laws I DO HEREBY, for myself and for my participating child, agree as follows:

1. My child’s participation in any Program means that I have inspected it to the extent I believe is necessary for careful consideration and that, although I ACKNOWLEDGE THAT THERE MAY BE A RISK OF SERIOUS INJURY (KNOWN OR UNKNOWN) IN ANY PROGRAM, I have determined that it is reasonably safe and suited for my child.
2. I consent to my child’s participation in any Program and my child’s assumption of the risks of that participation.
3. I am aware that any Program may be filmed and used for promotional purposes by Outdoor Recreation, the City of Albuquerque and any sponsors of the Programs. I HEREBY IRREVOCABLY GRANT to the City Of Albuquerque and any sponsors, their respective affiliated and related companies and any third parties they may authorize, the right to photograph my child and make recordings of my child’s voice at any Program, and the right to use pictures and other reproductions of my child’s physical likeness (as it may appear in any camera photograph and/or motion picture film or tape) and recordings of my child’s voice in any medium, in any form and without regard to whether any financial benefit accrues to any such user.
4. I RELEASE, COVENANT NOT TO SUE AND AGREE TO INDEMNIFY AND HOLD HARMLESS to the City Of Albuquerque, Parks and Recreation, Outdoor Recreation and any sponsors and their respective related, affiliated or subsidiary companies, and the officers, directors, employees, or agents of each (collectively, the “Releasees”) of and from any and all claims, causes of action, damages, liabilities or expenses (collectively, “Claims”), known or unknown, suspected or unsuspected, existing now or in the future, that my child or I may now or hereafter have against the Releasees, arising in any way out of my child’s participation in any Program (including the use of my child’s physical likeness or voice and reproductions or recordings thereof), and regardless of any fault or negligence on the part of the Releasees.

5. I ASSUME FULL RESPONSIBILITY FOR, AND ALL RISK OF, any bodily injury, death, or property damage suffered by my child or myself for any reason due to my child's participation in any Program.
6. If my child becomes injured or ill while participating in any Adventure, I hereby authorize an adult representative of the City Of Albuquerque to administer, or cause and consent to the administration of whatever first aid, medical care, dental care or other treatment and medications as may be necessary under the circumstances including treatment by a physician, dentist or hospital, although I hereby acknowledge that the City Of Albuquerque has no obligation to do so. I further acknowledge that the City Of Albuquerque does not endorse the services of any physician or hospital that may treat my child. I understand that I will be financially responsible for the cost of any such care, treatment or medication and that the Releasees will have no obligation to pay any such costs.
7. I have carefully read this agreement, and I know and understand what it means. My signature below is my own free act, and I intend it to be legally binding on me. This agreement constitutes the entire understanding between the City Of Albuquerque and my self regarding the subject matter hereof and supersedes any prior statements, agreement or representations, whether written or oral, regarding that subject matter.
