Dear Tribal Leader and Indian Health Program Administrator:

A primary goal of the California Area Indian Health Service is to ensure that Tribal Health Program's are prepared in the event of an influenza pandemic. I have enclosed important information that provides County Health Department, Indian Health Clinic/Center, and Tribal Government contact numbers for your reference if an influenza pandemic occurs. The California Area Office has prepared the information in collaboration with the State of California Department of Health Services.

If an influenza pandemic occurs, it would be widespread throughout the world and require people to remain at home to avoid further spreading or coming in contact with the flu. An influenza pandemic occurs when a new strain of influenza virus appears; there will be little or no immunity in the population, including no vaccine. The virus can spread from person-to-person and the usual vaccine will not be of benefit since this will be a new virus.


As a leader in your community it is important to inform others to practice good health habits and avoid the spread of germs. Good health habits include eating healthy foods, exercising daily, and getting enough rest. To avoid germs, stay away from others who have the flu, cover your nose and mouth with tissue when sneezing or coughing, and wash hands with plenty of soap (two minutes) and rinse well.

I recommend you keep informed about national or international influenza outbreaks and inform your community. The local Indian Health Clinics will have seasonal influenza vaccine available. Currently, there is no vaccine developed for a pandemic flu outbreak.

The enclosed information will be distributed state-wide to the State Health Department, County Health Department and to the Tribal and urban ambulatory health care clinics/centers.
