SULFUR IN JUNE 2007

During the month, production of recovered elemental sulfur was 672,000 metric tons (t), according to the U.S. Geological Survey. June 2007 production was slightly higher than that of May 2007 and 3% lower than that of June 2006. Sulfur production for the first half of 2007 was slightly higher than that in the first half of 2006. Shipments were 2% higher than those of May 2007. Producers' ending stocks for June 2007 were 159,000 t.

Import and export data for June 2007 were not available at the time of publication and will be published in the Sulfur in July

2007 Mineral Industry Surveys along with apparent consumption. Imports of recovered sulfur for May 2007 were estimated to be 243,000 t; exports were 71,000 t. Imports of sulfuric acid for May 2007 were 223,000 t; exports were 26,000 t.

Significant adjustments have been made to the sulfur import data. Reports from the U.S. Census Bureau appear to underreport sulfur imports, especially material from Canada. The revised figures are based on Census information and data from personal communications with industry experts.
