### REQUIREMENTS:

In addition to class lectures on Mondays and Wednesdays, students will attend small group discussion sessions on Fridays. Students are expected to participate actively in these small groups. Students will write a 10 page term paper on a topic of their choice. When choosing a topic, students must meet and discuss the topic with their small group leader. The paper topic must be approved by no later than October 15. The small group leader and one other instructor will grade the papers. The two readers in consultation will determine the final grade.

#### EVALUATION:

Grades will be based on your performance on two exams, a midterm worth 20% of the final grade, and a cumulative final worth 35% of the final grade. The term paper grade will also represent 35% of the final grade. The last 10% of the grade will be based on your participation in the small groups. Small group instructors may make additional assignments of work that will count towards the small group grade.
