REQUIRED ASSIGNMENTS

Each student is responsible for purchasing the 3 required texts listed above for this elective and reading the appropriate sections from these texts prior to each class session. Each student is responsible for turning in a minimum of three typed questions at the beginning of each discussion session. These questions are to be based on the assigned readings and topics for that specific seminar session. Each student is required to write a 6-10 typed, double spaced page research paper on any history of medicine subject jointly agreed upon by the student and either Drs. Benedek or Erlen. These papers must demonstrate effective use of both primary and secondary literature (translations are secondary sources) and should be turned in two days before the end of the elective for the students to receive credit for this elective. For elective blocks 7-10 no research paper will be accepted after Friday April 23, 2004. For elective block 11 all student papers must be turned in by Friday, May 7, 2004. Students who fail to meet these deadlines for their research paper will receive a failing grade in this elective. Students have to attend all seven in-class seminar sessions and actively participate in the in-class discussions. If a student misses any session they must turn in an additional 10 typed page report analyzing the reading assignments for the missed session. Students are also required to attend all additional programs assigned during their elective block, i.e., meetings of the C. F. Reynolds Medical History Society and Medicine Grand Rounds when appropriate.
