#### About this Course

This course is about the rise of modern surgery and how this process was interrelated with a change in the body concepts and images. We will discuss both the history of surgery and the history of the body and then relate them to each other, using particular case examples. At the same time we are going to put both issues into the context of other changes that occurred in emergence of modern societies.
