SILVER IN MAY 2007

U.S. mines produced 101,000 kilograms (kg) of silver in May, a 6% increase compared with April production of 95,700 kg, according to the U.S. Geological Survey. The daily production rate of silver in May was 3,270 kg, 2% higher than the April rate of 3,190 kg and 4% more than the 2006 annual daily production rate of 3,120 kg. Silver production in the United States in May increased by about 10% compared with May 2006 production of 90,900 kg.

Englehard Industries' silver price peaked at \$13.58 per troy ounce on May 7 and averaged \$13.20 per troy ounce in May, a 4% decrease from the average April price of \$13.78 per troy ounce, and almost the same as the average May 2006 price of \$13.51 per troy ounce.

Apex Silver Mines Ltd. (Denver, CO) reported a preliminary net income of \$112 million for the first quarter 2007 compared to a loss of \$174 million for the first quarter 2006. Construction at the San Cristobal project, southwestern Bolivia, is nearing completion. Crushing, conveying, grinding, and flotation circuits are being tested, and the first sale of concentrates was expected in the third quarter of 2007 (Apex Silver Mines Ltd., 2007).

Esperanza Silver Corporation (Vancouver, British Columbia, Canada) announced drill results from its joint-venture San Luis

property in central Peru. In one drill hole, SL-064, on the Ayelen vein, an 8-meter interval averaged 21.1 grams per ton (g/t) gold and 628.2 g/t silver. Silver Standard Resources Inc. (Vancouver, British Columbia, Canada) holds 55% interest in the San Luis property, and Esperanza holds 45% interest (Esperanza Silver Corporation, 2007).

Analysts said that exchange traded-funds (ETFs) have the potential to absorb a large part of the above-ground silver supply, making silver ETFs more attractive. Since 1999, silver prices have risen from between \$4.00 and \$6.00 per troy ounce, and since 2006, silver has sold in a broad range from \$9.00 to \$15.00 per troy ounce (Prakash, 2007).
