SILVER IN DECEMBER 2007

U.S. mines produced 97,800 kilograms (kg) of silver in December, a 6% increase compared with revised November production of 92,000 kg and a 9% increase compared with revised October production of 90,000 kg, according to the U.S. Geological Survey. The daily production rate of silver in December was 3,160 kg, 3% higher than the revised November daily production rate of 3,070 kg and about 9% higher than the revised October production rate of 2,900 kg. The December production rate was slightly higher than the 2006 annual daily production rate of 3,120 kg. Silver production in the United States in December 2007 was about the same as December 2006 production of 98,300 kg.

Englehard Industries' silver price peaked at \$14.80 per troy ounce on December 31 and averaged \$14.37 per troy ounce in December. This was a 3% decrease from the average November price of \$14.72 per troy ounce, and a 7% increase compared with the average December 2006 price of \$13.37 per troy ounce.

Silver production from Idaho's Silver Valley was anticipated to be 150 metric tons (t) in 2007 and was projected to be 300 t in 2008. The anticipated increase was because of increased output at the Galena-Coeur mining complex and reopening of the Sunshine Mine (Platts Metals Week, 2007).

Revett Minerals Inc. (Spokane Valley, WA) received permission from the U.S. Forest Service to begin development of its Rock Creek Mine, an underground copper-silver project in

northwestern Montana. Rock Creek is expected to produce an average of 186 metric tons per year (t/yr) of silver for a 20-year mine life. The project was in the prefeasibility stage, and drilling to evaluate the deposit was scheduled to begin in spring 2008 (Revett Minerals Inc., 2007).

Sterling Mining Co. (Wallace, ID) announced that it has resumed production at the Sunshine Mine, one of the Nation's richest silver producers, in the Silver Valley, Idaho. The mine closed in 1982, and, since 2003, the company has worked to rehabilitate the mine and facilities in order to resume production. The first shipment of ore will be processed by Teck Cominco Ltd. at its Trail, British Columbia, Canada, smelter. Sterling anticipates production of 87 t silver for 2008 (Sterling Mining Co., 2007).
