* PHMSA revised the definition of a serious incident in 2002. This report uses the previous definition:

- a fatality or major injury caused by the release of a hazardous material,
- closure of a major transportation artery,
- the evacuation of 6 or more persons due to the presence of a hazardous material,
- a vehicle accident or derailment resulting in the release of a hazardous material
