SUBJECT: Selection of Respondents for the Antidumping Investigation of

Certain Steel Nails from the People's Republic of China

#### **Background**

On July 10, 2007, the Department of Commerce ("Department") requested quantity and value ("Q&V") information from 121¹ companies that Petitioners² identified as potential exporters or producers of certain steel nails ("nails") from the People's Republic of China ("PRC"). See Attachment I. Additionally, on July 10, 2007, the Department sent a Q&V questionnaire to the China Bureau of Fair Trade for Imports & Exports ("BOFT") of the Ministry of Commerce ("MOFCOM").

# **Q&V** Responses

### A. Companies Submitting Timely Responses to the Q&V Questionnaire

The Department received timely Q&V responses from 71 companies<sup>3</sup> that exported subject merchandise to the United States during the period of investigation ("POI"), October 1, 2006, through March 31, 2007. This includes two companies that reported that they neither produced nor exported the subject merchandise during the POI.<sup>4</sup>

# B. Companies Submitting Untimely Responses to the Q&V Questionnaire

The Department received untimely responses from six companies, which were rejected and will not be considered in the respondent selection process. See August 24, 2007, letters from Alex Villanueva, Program Manager, Re: Quantity and Value Questionnaire Response for Certain Steel Nails from the People's Republic of China Investigation: Rejection of Submission. We will address the treatment of these non-responsive companies in the preliminary determination.

# C. Companies Not Responding to the Q&V Questionnaire

The Department did not receive Q&V responses from the remaining 72 companies that were identified as potential exporters or producers of nails in the petition. See Attachment II. We will address the treatment of these non-responsive companies in the preliminary determination. In addition, we note that the Department did not receive a response to the Q&V questionnaire from MOFCOM.

# **Treatment of Certain Companies**

Of the 71 companies that submitted Q&V responses, 14 indicated they were either affiliated or comprised a single entity with other companies.<sup>5</sup> On August 13, 2007, we requested that these 14 companies provide the basis for their affiliation/single entity claims and that they separate their reported Q&V data by exporting entity. See Attachment III. In this supplemental questionnaire the Department requested that each party address the collapsing analysis found in the Department's regulations. See 19 CFR 351.401(f). We received responses from thirteen of the fourteen companies on August 20, 2007.<sup>6</sup>

## A. Shanxi Yuci Group

We determine that Shanxi Yuci Broad Wire Products Co., Ltd. and its reported affiliated companies (collectively "Shanxi Yuci") did not provide sufficient evidence to support that they are a single entity. Specifically, Shanxi Yuci failed to provide sufficient evidence indicating that there is a significant potential for the manipulation of price or production. For example, Shanxi Yuci did not provide evidence regarding intertwined business operations, such as sharing of sales information, involvement in production and pricing decisions, or significant transactions between the affiliated parties. See, e.g., 19 CFR 401(f)(2)(iii). Therefore, we will not consider the aggregated Q&V questionnaire response from Shanxi Yuci and instead will consider the Q&V data from each Shanxi Yuci entity separately for purposes of selecting respondents.

### B. Xingya Group

The Suzhou Xingya Nail Co., Ltd.; Senco-Xingya Metal Products (Taicang) Co., Ltd; Yunfa International Resources, Inc.; and Omnifast Inc. (collectively "Xingya Group") is composed of two exporter-producers. One exporter is sufficiently large that even when it is disaggregated from the group, it is the second largest exporter of subject merchandise by volume. See Attachment IV. Thus, for purposes of respondent selection, it is not necessary for the Department to determine whether to treat the Xingya Group as a single entity. Instead, and as discussed in more detail below (see "Selection of Respondents" infra) because the Xingya Group is one of the top two exporters, by volume, whether its data are used aggregated or separated by each exporting entity, we are selecting it as a mandatory respondent.

# C. Additional Companies

Even if the remaining companies are aggregated, their total volume of exports is sufficiently low such that none of them would be selected as a mandatory respondent. See Attachment IV. Thus, the Department need not determine whether to treat the remaining companies as a single entity for purposes of respondent selection. See "Selection of Respondents" infra. However, we will

submission, the Department finds that no individual Oriental Cherry company or Oriental Cherry collectively would have ranked above the selected mandatory respondents. The Department may, however, continue to consider Oriental Cherry and its reported affiliates for separate rate purposes, if an application is submitted by the appropriate deadline and once all Q&V clarifications have been sufficiently addressed by the companies. Because Oriental Cherry and its affiliates did not provide information regarding why they should be considered a single entity and originally provided disaggregated Q&Vs, we are treating each company which is part of Oriental Cherry as a single entity for the purpose of respondent selection.

examine these companies' claims in further detail in the context of the separate rate application.<sup>8</sup> For the reasons set forth below, we have determined that it is not practicable to examine all known exporters or producers of nails from the PRC.

# Issue 1: Limiting Examination to a Reasonable Number of Companies

Section 777A(c)(1) of the Tariff Act of 1930, as amended ("the Act"), directs the Department to calculate individual dumping margins for each known exporter or producer of the subject merchandise. However, section 777A(c)(2) of the Act gives the Department discretion to limit its examination to a reasonable number of exporters or producers if it is not practicable to examine all exporters or producers involved in the investigation.

After careful consideration of the number of exporters and producers that responded to our Q&V questionnaire, the complexities expected to arise in this investigation and our available resources, we have found that it would not be practicable in this investigation to determine individual dumping margins for each known exporter or producer of the subject merchandise. Office 9, AD/CVD Operations, is currently conducting the antidumping duty investigations of sodium hexametaphosphate, laminated woven sacks, and steel wire garment hangers. Moreover, Office 9 is conducting numerous administrative reviews, including the antidumping duty reviews of honey from the PRC, shrimp from the PRC and from Vietnam, glycine from the PRC, certain tissue paper products from the PRC, floor-standing, metal-top ironing tables and certain parts thereof from the PRC, frozen fish fillets from Vietnam, candles from the PRC, and fresh garlic from the PRC. Office 9 is also conducting four scope inquiries, ten new shipper reviews, and two remand determinations. Other offices within Import Administration do not have additional resources to assist Office 9 with its workload. Based on our analysis of the allegations and the workload required for this investigation, we believe that we can investigate no more than two companies.

### **Issue 2: Selection of Respondents**

Where it is not practicable to make individual dumping margin determinations for all known producers and exporters of subject merchandise, section 777A(c)(2) of the Act permits us to limit our investigation to: A) a sample of exporters, producers, or types of products that is statistically valid based on the information available at the time of selection; or B) exporters and producers accounting for the largest volume of the subject merchandise from the exporting country that can reasonably be examined. In selecting respondents in this investigation, pursuant to section 777A(c)(2) of the Act, we find that it is most appropriate to choose the exporters or producers that account for the largest volume of subject merchandise exported or shipped to the United States during the POI. By selecting the largest producers or exporters, the Department is able to individually examine the companies involved in producing and exporting the largest possible volume of subject merchandise.

We have attempted to determine what percentage of total imports the largest producers/exporters account for in this investigation. However, based on the available data, we have been unable to do so in this case. For example, the aggregate Harmonized Tariff Schedule of the United States (HTSUS) does not provide sufficient detail to correspond precisely with the scope of the investigation.

Therefore, we obtained information through the Q&V questionnaires on the quantity and value of nails shipped from the PRC to the United States during the POI. As discussed above, after assessing all of the above factors, we have determined that we can reasonably examine no more than two of the of the 71 exporters from which we received Q&V responses. After examining the submitted Q&V data and the additional collapsing information, see "Treatment of Certain companies" supra, the two exporters or producers accounting for the largest volume measured by total metric tons of subject merchandise shipped during the POI are Paslode Fasteners (Shanghai) Co., Ltd. and Xingya Group. An analysis of the Q&V submissions reveals that, of the companies that submitted Q&V responses, these two exporters or producers of the subject merchandise account for [ ] percent of exports with respect to companies that responded to the Department's Q&V questionnaire. See Attachment II. Given these companies volume of exports, the Department finds that individual examination of these two companies is a reasonable basis upon which to conduct this investigation.

#### **Recommendation:**

We recommend selecting as the mandatory respondents in this investigation:	Paslode Fasteners
(Shanghai) Co., Ltd. and Xingya Group., the two exporters with the largest vo	lume of
exports/shipments to the U.S. market during the POI.

# **<u>Issue 3</u>**: Whether to Investigate Voluntary Respondents

Section 782(a) of the Act directs the Department to calculate individual rates for exporters/producers that provide information voluntarily, except where the number of such

respondents is so large that the calculation of individual dumping margins for all such respondents would be unduly burdensome and would prevent the timely completion of the investigation. However, for the same reasons noted above, it would not be practicable for the Department to investigate more than the above-named respondents in this investigation. That is, calculation of individual dumping margins for any additional respondents would be unduly burdensome and would prevent the timely completion of this investigation. Therefore, as long as the selected respondents cooperate in this investigation, we will not be able to calculate individual rates for voluntary respondents.

### **Recommendation:**

We recommend not calculating individual dumping margins for any non-selected companies that may place full responses on the record. If, however, a mandatory respondent fails to cooperate, the Department does not select another mandatory respondent, and companies that wish to be treated as voluntary respondents have submitted complete and timely responses, we may select a voluntary respondent under the following conditions:

- 1. Pursuant to section 782(a) of the Act, the voluntary respondent must have met filing deadlines for information requested (and otherwise comply with all other regulatory deadlines);
- 2. If there is more than one potential voluntary respondent, we will select the voluntary respondent based on the order in which written requests to be accepted as voluntary respondents are submitted. See Antidumping Duties; Countervailing Duties: Final Rule, 62 FR 27296, 27310 (May 19, 1997).
- 3. Once selected, a voluntary respondent that subsequently fails to cooperate in the investigation will be treated in the same manner as a mandatory respondent who fails to cooperate. See section 776(b) of the Act and 19 CFR 351.204(d)(2).

Finally, pursuant to section 19 CFR 351.204(d)(3), the Department will exclude any individually calculated rates for voluntary respondents from the calculation of the all-others rate under section 735(c)(5) of the Act.
