Chairman Lenhard recognized Mr. Jonathan Levin of the General Counsel's Office who presented draft Advisory Opinion 2007-12 regarding the application of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Commission regulations concerning the proposed disaffiliation of Tyco US PAC from the separate segregated funds (SSFs) of two other corporations that are domestic subsidiaries of companies that have been spun off from a corporate parent of Tyco US.

During his presentation, Mr. Levin noted the following amendments:

<u>Page 2, footnote 2, fifth line</u> – delete the word "gave" <u>Page 12, line 4</u> – change "may own" to "may have owned" <u>Page 15, line 12</u> – delete the word "mentioned."

Chairman Lenhard recognized Vice Chairman Mason, who

MOVED to approve draft Advisory Opinion 2007-12, as set forth in Agenda Document No. 07-57, subject to the amendments noted above.

The motion carried on the vote of 5-0.
