Your Committee on Finance, to which was referred H.B. No. 1023 entitled:

"A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE V, SECTION 1, OF THE HAWAII CONSTITUTION, TO CHANGE THE AGE QUALIFICATION FOR THE OFFICES OF GOVERNOR AND LIEUTENANT GOVERNOR FROM THE AGE OF THIRTY YEARS TO THE AGE OF TWENTY-FIVE YEARS,"

begs leave to report as follows:

The purpose of this bill is to expand the pool of individuals eligible for the offices of the Governor and Lieutenant Governor by proposing a constitutional amendment to lower the age qualification for the two offices from the age of 30 years to 25 years.


Several concerned individuals testified in support of this bill.
