The purpose of this bill is to provide for more efficient
financial operations at the University of Hawaii (UH) by limiting
UH's duty to preaudit all proposed payments to those that amount
to \$10,000 or more.


UH testified in support of this bill. The Department of

Your Committee has amended this bill by changing the
effective date to July 1, 2050, to promote further discussion.


