"A BILL FOR AN ACT RELATING TO LONG-TERM CARE OMBUDSMAN,"

beg leave to report as follows:

The purpose of this bill is to improve safety and services for residents of long-term care facilities by expanding the longterm care ombudsman program by adding three additional ombudsman positions, one for each neighboring county.

The National Association of Social Workers, ILWU Local 142, Policy Advisory Board for Elder Affairs, and several concerned individuals supported this bill. AARP supported the intent of this measure. The Department of Health and Executive Office on Aging submitted comments.

Your Committees have amended this bill by:

- Repealing the requirement that written consent be acquired from a resident of a long-term care facility or the resident's legal representative prior to the longterm care ombudsman gaining access to the resident's records; and
- (2) Making technical, nonsubstantive changes for clarity, consistency, and style.
