Your Committee on Public Safety & Military Affairs, to which
was referred H.B. No. 2463 entitled:

"A BILL FOR AN ACT RELATING TO DISASTER RELIEF,"

begs leave to report as follows:

The purpose of this bill is to enhance the state's ability to
recover from disasters by:

- (1) Authorizing the Director of Disaster Relief to use
inmate labor to assist with disaster relief efforts; and
- (2) Establishing the inmate disaster relief labor program
within the Department of Public Safety (DPS).

The Department of Defense and a concerned individual
supported this bill. DPS supported the intent of this measure.

Your Committee has amended this bill by:

- (1) Directing the Director of Disaster Relief to work with
DPS in coordinating disaster relief plans using inmates;
and
- (2) Making technical, nonsubstantive changes for clarity,
consistency, and style.




