Your Committee on Health, to which was referred H.B. No. 3152
entitled:

"A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE
DEPARTMENT OF HEALTH FOR THE EMERGENCY MEDICAL SERVICES AND
INJURY PREVENTION SYSTEM BRANCH,"

begs leave to report as follows:

The purpose of this bill is to appropriate \$1,807,539 as an
emergency appropriation to reimburse costs associated with
ambulance service contract collective bargaining increases
negotiated by the ambulance services provider for Oahu, the City
and County of Honolulu.

Pursuant to the requirements set forth in Article VII,
Section 9, of the Hawaii Constitution, the Governor, in her
Governor's Message No. 241 to the Legislature, requested immediate
consideration and passage of this bill, citing an existing
critical funding emergency to continue ambulance services on Oahu.

The Department of Health supported this bill.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of H.B. No.
3152 and recommends that it pass Second Reading and be referred to
the Committee on Finance.
