The purpose of this bill is to require the Department of Land and Natural Resources (DLNR) to provide a comprehensive report on the status of the state's marine ecosystems and to appropriate funds to perform the study.

The Nature Conservancy of Hawaii, Hawaii Nearshore Fishermen, and a concerned individual testified in support of this bill. Conservation Council for Hawaii and KAHEA: The Hawaiian-Environmental Alliance opposed this measure. DLNR provided comments.

Your Committee has amended this bill by:

- (1)Removing the appropriation amount to encourage further discussion:
- Changing the effective date to July 1, 2020; and (2)
- Making technical, nonsubstantive amendments for clarity, consistency, and style.

No. 3391, H.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 3391, H.D. 2.
