entitled:

"A BILL FOR AN ACT RELATING TO EDUCATION,"

The purpose of this bill is to provide more flexibility to
teachers to purchase school supplies and other related curriculum
support supplies by allowing the principal of each public school
to establish and use a debit card system.

The Representative of the 27th District testified in support
of this bill. The Hawaii State Teachers Association supported the
intent of this measure. The Department of Education opposed this
measure.

Your Committee has amended this bill by:

- (1) Changing its effective date to July 1, 2020, to
facilitate further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity,
consistency, and style.


As affirmed by the record of votes of the members of your
