Your Committee on Finance, to which was referred H.B. No. 844
entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION FOR THE PURCHASE
OF REAL PROPERTY IN WAHIAWA, OAHU,"

begs leave to report as follows:

The purpose of this bill is to appropriate funds for the
acquisition, maintenance, and planning for future recreational
uses of Lake Wilson, located in Wahiawa on the island of Oahu, to
preserve its utility as an agricultural irrigation asset and
outdoor park and water recreation site and ensure the proper
maintenance of the Wahiawa Dam.

The Dole Food Company Hawaii testified in support of this
bill. The Department of Land and Natural Resources, Agribusiness
Development Corporation, and Bank of Hawaii as Trustee of the
trust established by the Estate of George Galbraith (deceased)
provided comments.

Your Committee has amended this bill by:


- (1) Changing the effective date to July 1, 2020, to
encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for style,
clarity, and consistency.
