"HOUSE CONCURRENT RESOLUTION REQUESTING THE ESTABLISHMENT OF  
A RELATIONSHIP BETWEEN THE STATE OF HAWAII AND THE ISLANDS OF  
POLYNESIA,"

The purpose of this concurrent resolution is to promote  
global connectivity among the islands of Polynesia and encourage  
meaningful and mutually rewarding cultural, social, economic, and  
political collaboration by requesting the Governor to establish a  
relationship between Hawaii and the islands of Polynesia.

Prior to the public hearing on this measure, your Committee  
distributed a proposed H.D. 2, which specified a list of  
jurisdictions to be included when establishing the relationship.

The Office of Hawaiian Affairs, Kamehameha Schools, Bishop  
Museum, Iolani Palace, Council for Native Hawaiian Advancement,  
Hawaiian Political Action Council of Hawaii, and a concerned  
individual supported the measure.


Your Committee has amended this measure by incorporating the
