Your Committee on Legislative Management, to which was referred H.C.R. No. 15, H.D. 1, entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE AUDITOR TO ASSESS THE SOCIAL AND FINANCIAL EFFECTS OF REQUIRING HEALTH INSURERS TO OFFER COVERAGE FOR HEARING AIDS,"

The purpose of this concurrent resolution is to assist persons suffering from hearing loss by requesting the Auditor to conduct an impact assessment report of the social and financial impacts of mandating coverage for hearing aids for Medicaid.


