She is a retired school teacher of thirty years, now physically disabled and significantly visually impaired, the current President of Hui Kupuna VIP, a senior group of visually impaired persons, and a member of the Working Group to develop the 2008 Interagency Action Plan for the Emergency Preparedness of People with Disabilities and Special Health Needs.

Nominee Can currently serves as a member of SILC. She has been a certified nursing assistant and caregiver for seventeen years, a longtime public transportation and paratransit advocate, is a founding member/owner of the Paradise Home Care Cooperative set to open in June 2008, and a member of the Puna Community Development Plan Mass Transit Working Group.

Nominee Meehan currently serves as the Chair of SILC. has considerable work experience in independent living and the development of independent living outreach services and centers, including directorship of the Tri-County Independent Living Center, advocate with the Association of Independent Living Centers of Utah, and outreach coordinator for the Hawaii Centers for Independent Living. She is also an individual with a disability, and has been a longtime advocate for persons with disabilities.

Upon review of the testimony, personal history, and statements submitted by the nominees, your Committee finds that the nominees have the necessary qualifications to serve on the Statewide Council on Independent Living.
