The purpose of this measure is to increase the loan ceiling for farm and ranch operations on Hawaiian home lands from \$50,000 to \$200,000.


Testimony in support of this measure was submitted by the Department of Hawaiian Home Lands. The Office of Hawaiian Affairs submitted testimony in support of the purpose and intent of this measure.

Your Committee finds that the existing loan ceiling of \$50,000 has not been adjusted since 1982. Your Committee further finds that in order to support and nurture viable farm and ranch operations on Hawaiian home lands, the loan ceiling of \$50,000 should be increased to \$200,000.

Your Committee has amended this measure by inserting the requested amendments into the most recent version of Section 215 of the Hawaiian Homes Commissions Act, 1920, as amended; and
