The purpose of this measure is to request that the University of Hawaii Natural Disaster Preparedness Training Center include in its work program a component that addresses the needs of Hawaii's at-risk elderly and persons with disabilities.

Testimony in support of this measure was submitted by the Disability and Communication Access Board and the University of Hawaii System.

Your Committees find that an island state is vulnerable to many types of natural hazards, including floods, earthquakes, and brush fires, and that maximum preparedness is the key to recovery from any such events occurring in the State.
