With regard to the first-phase rate change for the current fiscal year from February 1, 2005 to June 30, 2005, a Pre-Hearing Conference was held on December 17, 2004 and the Technical Hearing was held on January 10, 2005. The public was invited to attend and participate at both hearings. For the first-phase of the change in rates, a typical residential customer's monthly bill has been increased to \$47.09, an increase of \$5.33 a month, or a total of 12.8 percent. A Pre-Hearing Conference for the second, third and fourth phase of proposed rate changes was held on February 1, 2005.
