Department Application for High School Interns: Summer 2008

The following application is for City departments and offices to request a High School intern. Please feel out the application completely and submit electronically to: mip@phila.gov by March 28, 2008.

Program Overview

The City's High School internship program is a **6-week paid summer internship program for Philadelphia high school students** (sophomore to senior year) beginning in July 2008. One-hundred (100) high school interns will be placed in City departments and offices and will be assigned to various administrative and support tasks, while also participating in weekly workplace and leadership development trainings. Intern salaries will be provided by the City of Philadelphia and will not be the responsibility of the host department. These one-hundred (100) high school interns may be *in addition to* any other high school interns a department hosts over the summer (ex: through Philadelphia Academies or other community-based organizations), with the exception of the Department of Recreation.

The **minimum weekly commitment** for high school interns is **16 hours/week** and an additional **4 hours/week** are spent participating in **workplace and leadership development activities** -- facilitated by the Philadelphia Youth Network and the Office of Leadership Investment -- typically on Fridays, outside of the department.

Department expectations when hosting a high school Intern:

- Each intern will be assigned to a supervisor, with no supervisor assigned more than two (2) interns.
- Each intern will be assigned a mentor within the department (does not have to be the supervisor) who will meet with their intern on a weekly basis. Department mentors may be assigned up to five (5) interns.
- Intern applicants will be forwarded to departments/offices in May 2008 (upon initial interview with Philadelphia Youth Network and in-depth interview with Office of Leadership Investment staff).
- Intern supervisors and mentors are required to participate in a training in May 2008.
- Department supervisors and mentors must be available to host interns from July 7, 2008 to August 18, 2008.
