8 sewage; revising site application and water table monitoring fees; amending Rules and
9 Regulations No. 99-01, as amended, and Title 13 of the Code of the King County Board
10 of Health, enacted pursuant to RCW 43.20.050, RCW 70.05.060 and WAC 246-272,
11 including the latest amendments or revisions thereto.

13 BE IT ADOPTED BY THE KING COUNTY BOARD OF HEALTH:

15 **SECTION 1.** Section 13.74.010 of the Code of the King County Board of Health is hereby
16 amended to read as follows:
