Agreement between the Parties to the North Atlantic Treaty for the Security of Information

Done: Brussels; March 6, 1997

In accordance with Article 6, paragraph (a), the Agreement was open for signature by the Parties to the North Atlantic Treaty and is subject to ratification, acceptance or approval. Instruments of ratification, acceptance or approval shall be deposited

with the Government of the United States of America.

Entry into force: August 16, 1998

In accordance with Article 6, paragraph (b), the Agreement entered into force thirty days after the date of deposit by two signatory States of their instruments of ratification, acceptance or approval. It shall enter into force for each other signatory State thirty days after the deposit of its instrument of ratification, acceptance or approval.

In accordance with Article 7, the Agreement shall remain open for accession by any new Party to the North Atlantic Treaty, in accordance with its own constitutional procedures. The Agreement shall enter into force for each acceding State thirty days after the day of the deposit of its instrument of accession.
