FY 2004 Distribution of the Expanded Food and Nutrition Education Program

Funding Authorized under Section 3 (d) of the Smith-Lever Act

Attached is a tabulation reflecting your institution's share of the fiscal year (FY) 2004 formula allocation. For the first time since the program's inception, the amount appropriated by Congress was less than the FY 1981 funding level. This event triggered discussions between the Funds Management Section of the Cooperative State Research, Education and Extension Service and the Office of General Counsel for the Department of Agriculture on the proper method of allocation. This accounts for the delay in making these funds accessible, and we apologize for any inconvenience.

The allocation derived for the current funding level utilized the funding "rate" for each participating state or territory in FY 1981 and was applied to the current funding appropriated for FY 2004. Funding for those territories not participating in FY 1981 had their allocations calculated using the rate of decrease over FY 2003. Budget totals for FY 2004 for the Expanded Food and Nutrition Education Program can either be incorporated in the Smith-Lever Budget form if this form has not already been submitted or submitted via the attached form.
