SUBJECT: CHILD SUPPORT PROGRAM - REPAYMENT SHARING RATIOS FOR FEDERAL FISCAL YEAR 2001

This is to provide you with the new repayment sharing ratios for the Federal Medical Assistance Percentages (FMAP) for Federal Fiscal Year (FFY) 2001. The rates are to be used in determining the federal, state and county shares of child support collections on the CS 800 Reconciliation and Worksheet (CS 802) and for completion of the Child/Family and Spousal Support Payments - Assistance Related Distribution/Disbursement Summary Report (CS 800).

These percentages will be effective October 1, 2000 through September 30, 2001. FMAP sharing ratios will decrease from the FFY 2000 rate of 51.67% to 51.25% for FFY 2001. The new repayment ratios are as follows:
