SUBJECT: CHILD SUPPORT PROGRAM – REPAYMENT SHARING RATIOS FOR FEDERAL FISCAL YEAR 2004

This letter provides the new repayment sharing ratios for the Federal Medical Assistance Percentages (FMAP) for Federal Fiscal Year (FFY) 2004. The rates are used to determine the federal, State and county shares of child support collections on the Monthly Report of Collections and Distributions (CS 34) and Assistance Related Distribution/Disbursement Summary (CS 35).

These percentages are effective October 1, 2003 through September 30, 2004. The FMAP sharing ratio of 50% remains the same as FFY 2003.

Aid Code 32, TANF Timed Out (20% Hardship), and Aid Code 3W, TANF Legal Immigrants Timed Out (20% Hardship), have been redefined to the federal aid category. The Department of Social Services has informed us that the federal government will be sharing in the funding of these aid codes under the 20% hardship provision. Therefore, the federal repayment sharing ratio must be applied to the child support collections for these aid codes.
