Philadelphia More Beautiful Committee



The Philadelphia More Beautiful Committee (PMBC), a part of the Streets Department's Sanitation Division, promotes civic pride, public safety, and neighborhood empowerment. PMBC fosters an urban environmental partnership between the city and its citizens. PMBC approaches City-wide improvement at its smallest organized level: the city block.

PMBC coordinates the army of over 6,600 registered Block Captains, who perform a vital function in our City—they lead the battle against litter and blight that threaten our neighborhoods.

Block Captains are citizen leaders, who enlist the support of their neighbors to organize volunteer block cleaning events on designated days. PMBC Clean Block Officers work with Block Captains and other

Community Group Leaders to organize these Clean Block Events. PMBC provides these citizen volunteers with the tools and supplies necessary for cleaning their blocks, and arranges for the Sanitation Division's vehicles to collect the trash and debris generated by these events.

PMBC further serves as a liaison between city government and its citizens by distributing informational materials on services related to the Sanitation Code, as well as other city services. As part of PMBC's ongoing effort to expand the Clean Block Program, Clean Block Officers attend block club and community meetings upon request.

PMBC has scheduled the following Saturdays for Clean Block events. To participate when your area is scheduled for cleaning, please contact your PMBC Clean Block Officer. A list of Clean Block Officers and their phone numbers is included on the other side of this brochure. Interested participants should call at least three (3) weeks in advance of the listed cleaning date on which they wish to schedule a Clean Block event.

What you should know about Clean Block events:

- All debris should be bagged and placed at either end of the block to facilitate collection.
- No bulk or household trash will be collected during the Saturday Clean-up Program.
- Do not sweep trash or dirt into inlets.
- Streets should not be blocked off with parked cars during cleaning.
